**INSTRUCTION TO THE CANDIDATES APPEARING IN THE WRITTEN EXAMINATION FOR THE  
POST OF INSPECTOR OF DRUGS**

The issuing of e-admit card is subject to the condition that if ineligibility is detected at any stage, the candidature will be cancelled. The candidate must note the Board will take up the verification of eligibility condition i.e. age, educational qualification and caste, PWD etc. with reference to the original documents only after the candidate has qualified for the viva-voce.

**INSTRUCTIONS:**

1. Immediately after downloading the e-admit card the candidate should check it very carefully and bring to the notice of the Medical and Health Recruitment Board discrepancies, if any without loss of time.
2. He/she must bring his/her Admit card to the Examination hall to secure admission.
3. Candidates are to reach examination hall at least 20 minutes before the Examination.
4. Candidates who are unable to download their e-Admit Card must furnish to the designated Supervisor (i) two copies of recent passport size photograph and (ii) any one of the identity proof documents such as Pan Card/Driving License/Passport/Voter ID Card/Bank Passbook containing Photograph ID Card issued by the Educational Institutions where he/she is studying presently/ID issued by Govt. or Public Sector undertaking etc.
5. The candidate will be admitted to take the examination at the Centre specified in the Admit Card only and at no other Centre.
6. No candidate will be admitted to the Examination Hall 20 minutes after commencement of the Examination.
7. The candidate should not bring any other paper except the e-Admit Card, Black ball point pen and original valid identity proof to the Examination Hall.
8. CANDIDATES ARE NOT TO ALLOWED TO CARRY ANY ELECTRONIC/MECHANICAL COMMUNICATION DEVICE INCLUDING MOBILE PHONE, BLUETOOTH, EARPHONE, TABLET ETC.
9. CALCULATORS, BOOKS, SCALE OR DRAWING INSTRUMENTS ARE NOT ALLOWED INSIDE THE EXAMINATION HALL. THE BOARD SHALL NOT BE RESPONSIBLE FOR SAFE CUSTODY OF MOBILE PHONES ETC. AND AS SUCH WILL HAVE NO LIABILITY IN CASE OF LOSS OR DAMAGE.
10. Candidate(s) found using or attempting to use any unfair means shall be liable to such punishment as the Board may decide which may include expulsion and debarring from examination.
11. Candidate must abide by the Instructions given by the Supervisor/Invigilator. Failure to do so will make the candidate liable for such punishment as the Board decide.
12. **The following items will be supplied to the candidates in the examination hall**
  - i. **The Question Booklet:** Please check that it is numbered. If it is not numbered please inform the Invigilator and get it changed immediately.
  - ii. **OMR Answer Sheet:** Please check that it is properly printed and not wrinkled or torn. If it is defective get it replaced. The Roll Number will have 5 (Five) digits. Carefully fill in the roll number in the allotted space of the OMR sheet.

Out of the above 2 (two) items candidates are permitted to take with them only the Question Booklet issued to them, after conclusion of the Examination. They must return the OMR Answer Sheet to the Invigilator on duty without fail.

13. The Question Booklet shall be in 3 series, namely A, B & C. The series mentioned in the Question Booklet should be marked in the space provided for the series in OMR Answer Sheet. OMR Answer Sheet without marking series shall not be evaluated.
14. No candidate shall be permitted to leave the Examination Hall until an hour has elapsed from the commencement of the examination, nor during the last 30 minutes of the allotted time without submitting the Booklets.
15. No candidate shall be allowed to go Toilet/Urinal during the last 30 minutes of Examination.
16. The candidate should hand over the OMR Answer Sheet personally to the Invigilator on duty before he/she leaves the Examination Hall.
17. The candidate must not indulge in copying, communicating with other candidates or resort to any misconduct in the Examination Hall. He/she will be disqualified if found doing so.
