ORDER

Whereas as per Section 4 (1) of The Assam Community Health Professionals' (Registration and Competency) Act, 2015 notified vide the Assam Gazette No. LGL.179/2014/19 Dated 29th May 2015, the Community Health Officers "**shall work at Sub-Centre level and any such places as may be determined by the Government from time to time**", and

Whereas, vide Order No. NHM/HRD/TP/671/2011-12/8514 dated 15/07/2017, transfers and attachments of all NHM Officials including Community Health Officers at District or Sub-District level or any level above Sub Center has been prohibited, and

Whereas, it has been observed that there are instances of CHOs being engaged at Health Institutions above Sub Center level by District or Sub District Level Officers in violation of the provisions of the Act and orders in force, and

Hence, if any Community Health Officer (CHO) works in any Health Institutions above the Sub Center level, it will be treated as violation of the said law, and disciplinary action including Termination of Contract may be initiated against the Community Health Officer, and

That, any Joint Director of Health Services of any district or other officers under him/her are found to be engaging Community Health Officers in Health Institutions other than Sub Centers shall be liable for disciplinary action as per law.

This order comes into force with immediate effect.
