Whereas, in view of prevailing COVID-19 pandemic, Govt. vide notification No. HLA.555/2011/427 dated 31st March, 2020 has cancelled all kinds of leaves of Doctors w.e.f. 31st March, 2020;


Whereas, it has come to the notice that Dr. Udayan Kr. Baruah, Jt. DHS, Dibrugarh have been out of head quarter without availing permission from the Deputy Commissioner, Dibrugarh and competent authority since 12-04-2020;

Whereas, Dr. Udayan Kr. Baruah, Jt DHS, being the head of the health care in the district, responsibility for managing all COVID care related arrangements lies on him and his absence has put the entire health system to risk and the innocent lives into danger;

Also, in view of the scheduled tour of Hon'ble Chief Minister and the Chief Secretary to the district on 13-04-2020, his presence in the head quarter for the Review meeting to be chaired by Chief Secretary was of utmost importance;

Whereas, his absence from duty without information tantamount to gross negligence and dereliction of duty during such a pandemic;

Therefore, in view of the gross misconduct, Dr. Udayan Kr. Baruah, Joint Director of Health Services, Dibrugarh, is placed under suspension under Section 6(1) of the Assam Services (Discipline and Appeal) Rules, 1964 with immediate effect pending departmental proceedings.


