**Notification**

In pursuance of the Advertisement No. NHM-37015/6/2019-NCD-NHM/8689 dated 06/07/2020 regarding Six (06) month Certificate course in Community Health (CCH), it is hereby notified to all the selected candidates to take note of the following:

1. The candidate will have to sign the “Undertaking/ Confirmation of the Candidature” in prescribed format and will have to send the soft copy of the same by mail on/or before 18<sup>th</sup> September 2020. The mail ID is – [SPO.NCD.ASSAM@GMAIL.COM](mailto:SPO.NCD.ASSAM@GMAIL.COM) with copy to [SPC.NCD.ASSAM25@GMAIL.COM](mailto:SPC.NCD.ASSAM25@GMAIL.COM). The format is attached as Annexure – A.
2. The **HARD COPY** of the “Undertaking/ Confirmation of the Candidature” is to be submitted at the O/o. Mission Director, National Health Mission, Christian Basti, Guwahati, Assam positively by 24<sup>th</sup> September 2020.
3. Those who fail to submit the “Undertaking/ Confirmation of the Candidature”, s/he will forfeit her seat in the course.
4. After submission of the “Undertaking/ Confirmation of the Candidature”, revised list of final selected candidates will be published in the NHM web site for admission;
5. Candidates will be required to sign the Legal Surety Bond at the time of joining with the respective In-Charge of the Programme Study Centre (PSC) and the same will have to be submitted by 10<sup>th</sup> October 2020 to the respective In-Charge, Programme Study Centre for serving period of three (03) years, in prescribed legal format.

The candidates will have to arrange Rs. 100 Non-Judicial Stamp Paper for the same, on their own.

The cost of the same will not be refunded to the candidates.

In case of failing to submit the Legal Surety Bond in letter and spirit by 10<sup>th</sup> October 2020, then the candidature will be deemed forfeited and other statutory obligations will imply on the candidate.

For eg. the candidate will have to return the Admission Fees @ Rs 15,000.00 to the NHM, Assam and other costs.

6. All the candidates including the NHM in service candidates will be assigned/transferred to the respective PSC for all required purposes including payment of stipend/remuneration and leave etc.
7. After joining, the candidate will have to fill up the hard copy of the IGNOU Application Form with all the documents.
8. The candidate will have to sign the IGNOU issued ID Card.
9. The superintendent of the Civil Hospital (PSC in charge) shall report the monthly attendance of the candidates to NHM State HQ for release of stipend/ honorarium/ remuneration to the candidates. Block Accounts Managers will be responsible for ensuring due and timely payment of candidates as per NHM norms.
