ORDER

No. HLB.400/2009/Pt.I/150

Dated Dispur the 8th April, 2011

In continuation of Government order No.HLB.400/2009/Pt.I/137 dated 17th January, 2011, the following procedure is laid down for deciding the postings in difficult areas for those doctors who have expressed their willingness to join the rural service :-

- 1) On receipt of the list of names of willing doctors to join the rural service, MD, NRHM, Assam will prepare a name list of all the doctors in order of the marks (percentage wise) secured by each of them in the final MBBS examination.
- 2) MD, NRHM will also, in advance, ascertain the nos. of Doctors required to be posted in the Health Institutions of the difficult area. This number shall be determined on careful consideration of the O.P.D. load, delivery load and the availability of Medical Officers in each of the institutions.
- 3) The willing Doctors from the list mentioned in Para (1) above will be picked up in order of their position in the name list and would be asked to choose any place of posting in the difficult area subject to requirement as mentioned in Para (2) above.
- 4) If 2 (two) or more Doctors appear at the same position in the name list mentioned in Para (1) above, they would be prioritised on the basis of their marks in 2nd MBBS examination. If 2 (two) or more students have the same marks in 2nd MBBS examination also, then the marks of the 1st MBBS examination shall be considered to prioritise their case.
- 5) If at any stage a person wants to shift from the rural posting chosen by him in favour of some other posting, the same will be considered by the MD, NRHM and in this case the benefit of rural service rendered by such person shall not be considered for any benefit to him in the matter of additional marks in the PG examination. However, the benefit of this period of rural service shall be given to the person who is posted in the difficult area in place of the outgoing person.
