SPEAKING ORDER

Read : The Show cause notice No. HLA. 322/2018/20 dated 31/07/2018.

Findings : Whereas, Dr. Kanchan Kumar Das was appointed as M&HO-I on 27/12/2008 and served till 07/09/2016 at Baihata Chariali MPHC, Kamrup (R). While serving as M&HO-I he was transferred to Karimganj CH, Karimganj vide order No. HLA. 633/2016/74 dated 07/06/2016. But he did not comply with the Govt. order and did not join in his new place of posting till date. He has been absent since then and his present whereabouts were also not known to the office. Whereas an enquiry was conducted by Joint Director of Health Services, Kamrup on the basis of which a show cause notice was served to Dr. Kanchan Kumar Das vide No. HLA. 322/2018/20 dated 31/07/2018. Dr. Das was charged with unauthorized absence since the time of his transfer i.e. September, 2016. Documentary evidence provided by Joint Director of Health Services, Kamrup also proves that he has been working at private nursing homes and also conducting operations in a private manner.

Whereas, the matter was enquired by the enquiry officer Smti. Pranati Mazumder, ACS, Deputy Secretary, Health & F.W Department and report submitted by the Enquiry Officer on 5th March, 2020 wherein Dr. Das was found to be engaged in private nursing homes by ignoring Government Notification for transfer to Karimganj and disobeying and also not handing over charge of the previous post.

Whereas, the enquiry report submitted by Joint Secretary to the Govt. of Assam, Health & F.W Department and enquiry officer dated 5th March, 2020 is hereby accepted by the authority.

Order : After careful examination of all facts & circumstances of the Departmental proceeding, the doctor concerned has been found to be working at private nursing homes. As such Dr. Kanchan Kumar Das will not be paid any subsistence allowance for the period of suspension and also his period of suspension will not be counted for any purpose.

Further, the departmental proceeding is hereby disposed off by reinstating Dr. Kanchan Kumar Das into Govt. service.

On his reinstatement, he is hereby posted as M&HO-I(Anaesthetist) at S.K.Roy CH, Hailakandi and further directed to join within 7 (seven) days.
