
SPEAKING ORDER

- READ** : 1) Letter of Jt. DHS, Dhubri dated 25th November, 2019 regarding arrest of Dr. Jakir Hussain, Sr.M&HO, Bogribari Model Hospital, Dhubri.
2) Show cause notice issued to Dr. Jakir Hussain, Sr.M&HO, Bogribari Model Hospital, Dhubri vide Govt. letter No.HLA.862/2019/10 dated 31/12/2019.
- ALSO READ** : 1) Enquiry Report submitted by Inquiry Officer on 18/1/2021.
- FINDINGS** : 1) Asstt. Inspector General Police (R), Assam vide their dated 19/11/2019 informed regarding arrest of Dr. Zakir Hussain, Gyneacologist posted at Bagribari MG Model Hospital, Dhubri in connection with Gauripur P.S Case No.1407/2019.
2) Jt. DHS, Dhubri vide letter dated 25/11/2019 informed that Dr. Jakir Hussain, Sr.M&HO, Bogribari Model Hospital was arrested on 03/11/2019 in connection with GPR P.S case No. 1407/19 u/s 304(A)/294/384/506/34 IPC R/W Sec.7 of PC Act' 1988 and he was in Police custody for more than 48 hours.
3) Dr. Jakir Hussain, Sr.M&HO, Bogribari Model Hospital, Dhubri was suspended from service w.e.f.03/11/2019 vide Govt. order No.HLA.862/2019/9 dated 31/12/2019 pending drawl of Departmental proceedings.
4) Show cause notice was issued to Dr. Jakir Hussain, Sr.M&HO vide Govt.letter No.HLA.862/2019/10 dated 31/12/2019 on charges of negligence of duty, misconduct and breach of trust in discharging his duty towards delivery of a baby in Bogribari Model Hospital, Dhubri.
5) Dr. Jakir Hussain, Sr.M&HO submitted his reply to show cause notice on 03/1/2020.
6) Dr. Jakir Hussain, Sr.M&HO was reinstated in Govt. service vide Govt. order No.HLA.862/2019/35 dated 18/1/2020 and posted at Dhakuakhana SDCH, Lakhimpur.
7) Departmental proceeding was initiated by appointing I/O and P/O vide Govt. order No. HLA.862/2019/37 dated 25/2/2020.
8) Inquiry Officer submitted his inquiry report on 18/1/2021 which concluded that the charges brought against Dr. Jakir Hussain, Sr.M&HO could not be established.
- ORDER** : On perusal of records, it appears that the charges of negligence of duty, misconduct and breach of trust in discharging the duty towards delivery of a baby in Bogribari Model Hospital, Dhubri against Dr. Jakir Hussain, Sr.M&HO, Dhakuakhana SDCH, Lakhimpur (the then Sr.M&HO, Bogribari Model Hospital, Dhubri) could not be established.



Therefore, the Govt. in Health & F.W Department is pleased to drop the Departmental proceeding drawn up against Dr. Jakir Hussain, Sr.M&HO, Presently working at Dhakuakhana SDCH, Lakhimpur with the following orders-

- a) The period of suspension of Dr. Jakir Hussain, Sr.M&HO will be treated as on duty for all purpose.
- b) Dr. Jakir Hussain, Sr.M&HO, Dhakuakhana SDCH, Lakhimpur is hereby transferred and posted as Sr.M&HO at S.K.Roy Civil Hospital, Hailakandi with immediate effect. In view of COVID-19 pandemic, he is directed to join in his new place of posting within 7(seven) days from the date of issue of this order.


