- 1. <u>Scale of Pay</u>: Academic Level 14, Rs. 1,44,200/- to 2,18,200/- and other allowances are admissible as per existing Government Rules.
- 2. <u>Age</u>: 55 years.

The upper age limit is relaxable as per Government of Assam Rules.

3. Qualification:

A. EO: Essential Qualification:

- A bachelor degree in Ayurveda from a University established by Law or a statutory Board/Faculty/Examining Body of Indian Medicine or its equivalent as recognized under Indian Medicine Central Council Act, 1970; and
- ii. A Post Graduated qualification in the subject or specialty concerned included in the Schedule to the Indian Medicine Central Council Act, 1970.
- **B. <u>DQ: Desirable Qualification:</u>** Priority shall be given to the candidates with Doctoral in Ayurveda.
- C. <u>Experience</u>: 10 years teaching experience in concerned subject or 5 years teaching experience as Associate Professor (Reader) in concerned subject or 10 years research experience in regular service in Research Councils of Central Government or State Government or Union Territory or University or National Institutions with minimum three papers published in a recognized journals.
- 4. Process of recruitment: Interview/Online Interview.

5. Application fees:

- i. Application must be accompanied with required application fee of Rs. 250/- (rupees two hundred fifty) only for General category candidates and Rs. 150/- (rupees one hundred fifty) only for OBC/MOBC/SC/ST (P)/ST (H) candidate.
- ii. No application fee is required for candidates having BPL certificate and PWD certificate.
- iii. Application fee should be deposited only, through Treasury Challan in the Head of Account "0210-Medical and Public Health-01-Urban Health Services-800-Other Receipt". The fees are not refundable and no other mode of deposit of fee other than through Treasury Challan, shall be accepted.

Candidates may pay the requisites fees (as admissible for the category mentioned above). Printed copy of Treasury Challan generated through GRAS should be submitted along with the application form. In Remarks column, candidate may write the post applied for.

6. Terms and Conditions:

i. Candidates need not submit any testimonials/certificate at the time of submission of online application. However, candidates have to produce their original testimonials regarding educational qualification, date of birth, caste, EWS, PWD, Treasury challan, working experience etc. along with the application form, at the time of interview. Self-attested copies of all testimonials/certificates will have to be submitted to the Board at the time of interview.

ii. Application form, which is incomplete in any respect, such as, without photograph and signature, is liable to be rejected summarily.

iii. Only those candidates who fulfill all the terms and conditions of the advertisement in respect of the post for which they are applicants shall be entertained. Others need not apply.

iv. The Candidates who are already in the Governmentservice, or in Government owned undertaking or other similar organizations/Corporations/boards/ or in private employment, may apply with intimation to present employer.
