- 2. Candidate having MCA (Master of Computer Applications) will get extra points of up to 5 (five) points based on BCA/MCA degree marks.
- 3. Candidates having experience in website development, programming, knowledge of networking, Data analysis, Database management, in-house software development etc. in any Government and Private sector will get extra points as mentioned below:-

- Required Age as on 01-01-2022: Minimum 21 years and maximum 38 years. The upper age limit is relaxable for the candidates of reserved categories as below:-OBC/MOBC – 3 years, SC/ST – 5 years
- 5. <u>**Remuneration:**</u>Rs. 25,000/- per month (with annual increment of 6% per annum). No other allowances shall be applicable.
- 6. Candidates will be shortlisted for calling to viva-voce on the basis of academic marks.
