	ORDER (19)

The petitioner Sri Anupam Hazarika is present. The Public Authority is being represented by Dr. Nitul Sarmah, SPIO cum Deputy Director, O/o the Director of Medical Education, Sixmile, Khanapara, Guwahati. The Commission is also in receipt of a written statement from both the SPIO as well as the First Appellate Authority, Health and Family Welfare Department, Govt. of Assam, Dispur, Guwahati.

08-02-2024

The petitioner filed an RTI petition on 04.04.2023 seeking information under 4 nos. of heads. He wanted information on the total nos. of patients treated/treatment given during the year 2022-23 in OPD, IPD, Emergency or any other mode in all the hospitals, civil hospitals, PHC, Dispensary and other such government hospitals of Assam. At point no. 2, he reiterated that he needs only the total amount of money collected in all the above mentioned government hospitals against OPD registration, various examinations like X-Ray, CT Scan, MRI, Scan, USG, Paying Cabin, Bed Charge etc. He also wanted to know the nos. of patients treated free of cost on account of the persons belonging to BPL or any other category. And finally at point No. 4 he wanted the Department to submit a total figure of amount of expenses that could have been collected if there was no free treatment in the hospitals.

Records in this Commission reflect that the SPIO, Health and Family Welfare Department, Dispur has transferred the petition vide his letter dated 12.04.2023 to Dy. Secy. Medical Education & Research Deptt, Dispur. On 17.04.2023 the Director Health Service (G) Hengrabari has transferred the same to the Directorate of Medical Education Khanapara. Similarly again on 19.04.2022, Medical Education & Research Deptt. Dispur had transferred the same to the Directorate of Medical Education Khanapara. Records also indicate that some replies were sent to the petitioner by some of the Medical colleges and Hospitals. Not satisfied with the response of the authority concerned the petitioner has moved the FAA, Health and Family Welfare Department, Govt. of Assam, Dispur vide his letter dated 22.05.2023. In that petition he has reiterated that what is requested to obtain is not individual data pertaining to some medical colleges or hospitals. He stated that the Health and Family Welfare Department, is the highest authority and accordingly he had requested the FAA to ensure submission of the documents to him.

Records also indicate that the First Appellate Authority vide its letter No. HLA.292234/16 dated 21.06.2023 has transferred the 1st Appeal petition to different other FAAs. Meanwhile the petitioner continued to get bits and pieces of information from different Medical Authorities but not figures for the entire state as he had desired. Finally the petitioner had moved this Commission for 2nd Appeal vide his letter dated 07.07.2023. In that Appeal he has stated that in his original RTI petition he had asked specifically total no. of patients treated with some fees or treated freely and also the amount of money collected from different categories of patients. Though he has received some data of some hospitals, but there is no way of confirming the total picture of the entire state.

In his written statement the SPIO, Directorate of Medical Education Khanapara has stated that all the information asked for from 9 (nine) nos. of Medical Colleges has been furnished to the petitioner. In respect of the newly established Medical Colleges information are not available because rest of the Medical Colleges have been started only recently.

The Commission observes that the petitioner has asked for total no. of patients treated and total amount of money collected on account of various kinds of treatment/examination in his 1st and 2nd query of his RTI petition. In his verbal averment, he stated that he will be satisfied with a specific reply on these two particular points.

In any case it is incumbent upon the Public Authority, Health and Family Welfare Department to be putting such details as voluntary disclosure in their website or in other public forum in consonance with the Section 4 of the RTI Act, 2005. Hon'ble Supreme Court and the Govt. of India have also been insisting on strict implementation of the Section 4 of the RTI Act by all the Public Authorities. It is not possible for an information seeker to be approaching and addressing individual institution for collecting some basic data which is, in the instant case, appears to be asked with bona-fide intention. Therefore the Commission directs the SPIO, Health and Family Welfare Department, Dispur, Guwahati, to collect the required data by itself and share the same not only with the petitioner but also to put the same as voluntary disclosure under Section 4 of the RTI Act, 2005 in their website. This process should be completed within 15 (fifteen) days from the date of receipt of this order.

With the above directions, Commission decides to dispose of this 2nd Appeal petition dated 07/07/2023.


