No.HLA./E-520485/333: In the interest of public service and in partial modification of the Government Notification No.HLA.01/2023/116, dated 16th March, 2024 in connection with the place of posting as shown against their names, are hereby modified and posted at new place of posting as shown against their names below.

Subject to discharge without notice and without assigning any reason thereof and subject to submission of notarized affidavit as per OM No.ABP.78/2021/01 dated 11/09/2021, the following Doctors on the recommendation of Medical and Health Recruitment Board, Assam vide their letter No.MHRB/54/M&HO-I/2023/4101 dated 12/03/2024 are hereby appointed as M&HO-I (in the rank of GDMO/Causality Officer/Lady Medical Officer) or its equivalent posts etc. temporarily and posted as shown against their names w.e.f. the date of taking over charge and until further order in the scale of pay of Rs. 30,000/- to Rs. 1,10,000/- with Grade Pay of Rs. 12,700/- plus other allowances as admissible under the rules.

The appointees should give undertaking as required by Finance (Bt.) Department letter No. BW-3/2003/Pt.-II/1, dated 25/11/2005.


