Ayurvedic College and Hospital, Guwahati-14, Assam under Medical Education & Research Department, Govt. of Assam as indicated below:-

1. **Name of Posts:** Assistant Professor (Ayurveda) in Govt. Ayurvedic College and Hospital, Guwahati-14, Assam under Medical Education & Research Department, Govt. of Assam.
2. **Number and reservation of posts:** 02 (two)

3. **Category of Disability:** Orthopedically handicapped with at least one arm and one leg, low vision. Hearing handicapped and blind may be considered if he/she can perform with aids and appliances.
4. **Scale of Pay:** Rs. 57,700/- to 1,82,400/-Academic Level 10.
5. **Age:** A candidate should not be more than 38 Years as on 01/01/2025. The upper age limit is relaxable as per Govt. norms/order/Decision as applicable.
  - a. The upper age limit is relaxable by (if applicable)-
    - i. 5 years for SC/ST candidate.
    - ii. 3 years for OBC/MOBC candidates as per Govt. Notification No.ABP.6/2016/9 dated 25/04/2018.
    - iii. For Persons with Disabilities (PWD) by 10 years irrespective of SC/ST/OBC and General Category of candidates as per Govt. Notification No.ABP.144/95/121 dated 28/10/2015.

6. **Process of Recruitment:** The selection procedure will be notified later on by issuing a notice. The Board will decide the procedure for selection in respect of the posts on the basis of the number of applications received.

7. **Process to Apply:**

To apply online visit <https://nhm.assam.gov.in> -> Recruitment -> **Medical and Health Recruitment Board, Assam.**

Candidates must use their mobile number and password to login.

After that, candidates can fill up the form for that given post.

8. **Application fees:**

- Application must be accompanied with required application fee of Rs. 250/- (rupees two hundred fifty) only for General category candidates and Rs. 150/- (rupees one hundred fifty) only for OBC/MOBC/SC/ST (P)/ST (H) candidate.
- No application fee is required for candidates having PWD certificate.
- Application fee should be deposited only, through Treasury Challan in the Head of Account “0210-Medical and Public Health-01-Urban Health Services-800-Other Receipt”. The fees are not refundable and no other mode of deposit of fee other than through Treasury Challan, shall be accepted.

**OR**

Fees can be deposited online using Government Receipt Accounting System-GRAS (Website: <https://assamegras.gov.in>). Candidates may pay the requisites fees (as admissible for the category mentioned above). Printed copy of Treasury Challan generated through GRAS should be submitted at the time of interview. In Remarks column, candidate may write the post applied for.

9. **Terms and Conditions:**

- i. Candidates are required to submit all testimonials/certificate at the time of submission of online application. However, original testimonials are to be produced regarding educational qualification, date of birth, caste, PWD, Treasury challan, working experience etc. along with the application form, at the time of interview. Self-attested copies of all testimonials/certificates will have to be submitted to the Board at the time of interview.
- ii. Application form, which is incomplete in any respect, such as, without photograph and signature, is liable to be rejected summarily.
- iii. Only those candidates who fulfill all the terms and conditions of the advertisement in respect of the post for which they are applicants shall be entertained. Others need not apply.
- iv. Candidates who are in Govt. service (both State & Central) or in Govt. owned undertaking or other similar organizations etc. shall have to apply through proper channel. They shall have to produce “No Objection Certificate” from the present Employer at the time of document verification, before Viva-Voce/Interview and they will have to submit release order at the time of joining.
