Agreed Compensation Packages for the post of _____

Remuneration

Leave

During a financial year, the Party will be entitled for a casual leave of 2 & $\frac{1}{2}$ days per month which can only be earned after completion of one month of service. Casual Leave lapses at the end of each financial year and cannot be carried forward or used for encashment.

In case of illness, the Party is obliged to inform the Mission Director immediately. If the illness lasts for more than 3 days, a medical certificate must be produced. No more than six sickness leave days will be recognized during one financial year. The casual leave and sickness leaves are over and above the holidays declared as per the Government of Assam.

Holidays

The Office will observe the same public holidays, as the Govt. of Assam.

Travel and subsistence

Where for the purposes of the Programme the Party may be required to travel outside HQ as per direction of the authority. The TA, DA will be given as per financial norms.

TDS

The society shall deduct income tax at source (TDS) as per Income Tax Act, which shall be deposited from the remuneration of the Party.
