## CORRIGENDUM NO.1

e-TENDER FOR ENTERING INTO RATE CONTRACT cum SUPPLY and EMPANELLMENT of DRUGS

This is with reference to TENDER REFERENCE NO: NHM/PROC/RC-DRUG/NEW-EDL/3040/2016-17/22420, DATE:-20.03.2017 for supply of drugs. The following amendments in the tender may be taken note of prior to submission of bids.

- Clause 3 :Eligibility Criteria POINT NO "K" (The bidder shall have existing 1. storage facility at Guwahati for maintaining stocks of drugs offered for supply or develop/hire storage facility within 45 days from date of signing of contract agreement. is omitted from the Tender.
- 2. Clause 4 TECHNO-COMMERCIAL BID COVER "A" POINT NO "U" : UNDERTAKING ON STORAGE FACILITY AT GUWAHATI (Undertaking that the bidder shall maintain storage facility at Guwahati for storage of minimum 20% of all ordered drugs for immediate supply during the rate contract period and that if such storage facility is presently not available, the bidder will develop/hire such facility within 45 days from the date of signing of contract agreement) is omitted from the Tender.
- 3. Clause 4 TECHNO-COMMERCIAL BID COVER "A" POINT NO '10' "B" "GENERIC NAMES" is amended to read as follows:

Tender has been called for in the Generic Names. The bidders should quote the rates for the generic products. The composition and strength of each product should be as per details given in Annexure-XIII. Any variation found will result in the rejection of the tender. No drugs shall be accepted in brand name either manufactured in India or imported from overseas.

4. Clause 4 TECHNO-COMMERCIAL BID - COVER "A" POINT NO "A" EARNEST MONEY **DEPOSIT** is amended to read as follows:

Earnest Money Deposit shall be for the amount indicated under Clause-7 of this document, in the form of Demand Draft/Banker's Cheque or Bank Guarantee of a Scheduled Bank valid for 6 months, favoring "State Health Society, Assam",. Earnest Money Deposit in any other form will not be accepted. Earnest Money Deposit will not earn any interest.
