E- Tender for establishing Dialysis Unit in PPP mode at District Hospitals.

This has reference to the e Tender No: NHM/NCD/NDP/2016-17/1133/3796, dated: 01/06/2017 for establishing Dialysis Unit in PPP mode at District Hospitals. The following amendments may be taken note of prior to submission of bids:

1. Section I, Clause 8 is amended to be read as follows:

All Bids must be accompanied by **Earnest Money Deposit (EMD)** which amounts to **Rs. 15. 00 Lakhs** (Rupees Fifteen Lakhs) only in the form of Demand Draft/Banker's Cheque/BG favouring "**State Health Society, Assam**". Tenders without EMD shall be rejected. Earnest Money Deposit in any other form will not be accepted. EMD will not earn any interest.

2. Appendix J. Sl no. 14 is amended to be read as follows:

All required consumables for adult and pediatric patients which also includes the following consumables:

- (a) Pyrogen Filter/ diasafe/ water purify filter
- (b) Disinfectant cleaning solution Hot Sterilant and Cold Sterilant.

3. Section IV, Sl no. II and Appendix A may be considered as follows:

Four dialysis machines plus one dedicated machine for infective cases **(4 + 1)** in each of the 25 nos. of District Hospitals.

4. Appendix H, Declaration by bidder, is amended to be read as follows:

5. Section VI, Sl no. 11 (j), is amended to be read as follows:

Quarterly review of performance and observance of terms & conditions shall be carried out by a committee which shall include CMO & Head of department of Nephrology of the Govt. Teaching hospital along with other members nominated by the authority. The report of this annual review shall form the basis of continuity of the contract during the period. The Service Provider shall provide a access to audit/monthly reports/ bills /invoices including service logs to the Authority regarding the use of the Dialysis Machines and Equipments, number of patients treated, the fees charged etc as required by the Authority.

6. Appendix L, Sl no. E (1) is amended to be read as follows:

Biocompatible, synthetic (e.g., polysulfone, **polyethersulphone**, polyacrilonitrile, polymethylmethacrylate) or modified cellulose membrane (e.g., cellulose acetate) should be preferred over unmodified.

The last date for bid submission is 24/07/2017 (upto 2 pm).

All other terms and conditions of the tender referred to above shall remain unchanged.
