With the reference to the subject cited above, I am to inform that, National Health Mission, Assam is in the process for implementation of Close User Group (CUG) Mobile Connection for ASHAs (Rural & Urban), ANMs and officials of Health & Family Welfare Department (State Health Service and NHM). Approximately 49,000 connections will be covered under the scheme.

Interested Telecom Service Provider willing to tie up partnership with National Health Mission, Assam for implementation of CUG scheme may make a **15 minutes presentation** on **26**th **July 2017 from 3:00 PM onwards** at the Conference Hall of Office of the Mission Director, National Health Mission, Assam, Saikia Commercial Complex, Srinagar Path, G. S. Road, Christianbasti, Guwahati – 6.

National Health Mission, Assam will pay a maximum of Rs. 100/- per month per connection (inclusive of all taxes) under the scheme.

The presentation should cover the points mentioned in the evaluation matrix enclosed as Annexure –A. Only authentic data should be presented. Providing wrong information may lead to cancellation of the partnership in later date also.

It is also requested to submit both soft copy as well as signed hard copy of the hands out of the presentation before the meeting.

Further, number porting to other service provider has to be hassle free and this should be the commitment of the service provider. A special mechanism should be put in place for this purpose.

The service provider should also deploy dedicated official for prompt contact and redressal of the complaints related to CUG and name and contact number of the official should be shared. It should also be part of the commitment of the service provider.
