CORRIGENDUM NO.1

e-TENDER FOR ENTERING INTO RATE CONTRACT cum SUPPLY and EMPANELMENT of DRUGS

This is with reference to TENDER REFERENCE NO: TENDER REFERENCE NO: NHM/PROC/ RC-DRUG/NEW-EDL/DROP & ADD/3363/2017-18/11517, DATE: 17/8/2017 for supply of drugs. The following amendments in the tender may be taken note of prior to submission of bids.

1. **Clause 4 TECHNO-COMMERCIAL BID - COVER "A" "ANNUAL TURNOVER "** is amended to read as :Annual turnover statement from sales of Drugs for 3 years i.e., 2013-14, 2014-15 & 2015-16 in the format given in Annexure-III certified by the Auditor/Chartered Accountant. The certificate of Auditor/Chartered Accountant must be accompanied by attested/notarized copies of audited "**Profit & Loss Statement**" and "**Balance Sheet**" of past three financial years (2013-14, 2014-15 & 2015-16).
2. **Clause 4 "TECHNO-COMMERCIAL BID" - COVER "A"** The bidder shall have existing storage facility at Guwahati for maintaining stocks of drugs offered for supply or develop/hire storage facility within 45 days from date of signing of contract agreement, **is omitted from the Tender.**
3. **Clause 4 TECHNO-COMMERCIAL BID - COVER "A": MARKET STANDING CERTIFICATE** is amended to read as follows: Bidder should have at least **3 years market standing (2014-15, 2015-16, 2016-17)** as a manufacturer for the items quoted in the bid.
4. **Clause 4 TECHNO-COMMERCIAL BID - COVER "A" EXECUTION OF SIMILAR CONTRACTS** is amended to read as: Details of supplies (Quoted items) made during the past 3 financial years 2014-15, 2015-16, 2016-17 supported by Attested/notarized Purchase Orders for each quoted items issued by clients in the specified format (**Annexure-IV**) must be submitted. Moreover minimum 3 Attested/notarized copies of supply orders by the bidder executed for Government organizations during the last 3 financial years 2014-15, 2015-16, 2016-17 must be enclosed.
5. **ANNEXURE-XIII : ITEMS WITH QUANTITIES:** Item sl no. 96, Halothane Inhalation 50 ml is amended to read as **Halothane Inhalation 250 ml bottle.**

6. ANNEXURE-XIII : ITEMS WITH QUANTITIES will be increased to 260, instead of 258.
New items included in Annexure-xiii (items with quantity) is as below:
