This is with reference to **TENDER REFERENCE NO: NO: NHM/PROC/ RC-REGN/3472/2017-18/ 28470, DATE:-30/12/17 FOR ENTERING INTO RATE CONTRACT cum SUPPLY OF ESSENTIAL CHEMICALS & REAGENTS.** The following amendments in the tender may be taken note of prior to submission of bids.

1. Clause No. 3 ELIGIBILITY CRITERIA:

A new point is incorporated as pt. no "L" that for the item No. 6 "**Rectified Sprit 450 ml**" and item No. 7 "**Methylated Sprit 500 ml**" - the bidder should be the license holder under the **Deptt. of Excise of the state of Assam** for either manufacture/sale/supply of Rectified Spirit & **Methylated Sprit** and the license of the bidder should be valid on the day of submission of Bid.

2. For the items in ANNEXURE-XIII- "ITEMS WITH QUANTITIES" and ANNEXURE-XII- "PRICE BID/BOQ": the following Certification is required along with the bid and without the same the item will not be technically accepted.
