Bidder shall have experience in executing similar contracts in the last 5 (five) financial years 2012-13,2013-14,2014-15,2015-16,2016-17. The total value of the orders/agreements awarded by any Govt. Organisation /Undertaking during any three of the last five financial years must not be less than Rs.180.00 Lakhs. The turnover from such orders/agreements shall be given through a certificate from the Chartered Accountant as given in Annexure IV.

3. <u>Sub-Clause(h)"Execution of similar contracts of Bidder" under Clause 5 is amended to read as</u> follows:

Details of tickets supplied made during the last 5 financial years with summary of **Purchase Orders/Agreements and Performance Certificates** issued by clients in the specified format (Refer **Annexure IV**). Tickets supplied to Govt. institutions and to programs sponsored by WHO, UNICEF etc., if any, during the last 5 financial years should be highlighted. The Certificate of such **Orders/Agreements** awarded by a Govt. Organization of value as per sub-clause E of Clause 3 above executed during the last 5 financial years should be submitted after due certification by Chartered Accountant.

- 4. The scope of work which reads as "However, the hotel bill shall be settled by the official concerned" under HOTEL BOOKINGS at Annexure 1 "SCOPE OF WORK "shall stand deleted.
