- (a) Registered APWD (Bldg)ClassI-(A)/(B)/(C)/CPWD/Reputed Construction Company/Agencyregistered underGovt/Public Sector undertaking.
- (b) Contractor must have satisfactory completed:-
- i).Two similar works, each of value not less than 50% of the estimated cost put- on tender or
- ii).One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited. (c)Contractor must have achieved average Annual Turnover of at least 30% of estimated costduring last 3 years ending31stMarchof theprevious Financial Year.
- (d)The Contractor having PAN Card/GST Registration/Labour-License/registration under EPF & MPAct,1952etc.are eligible to participate in the bid process.
- (e) In case the evaluated bid amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital Building projects on earlier occasion.
- (f) The intended bidders are asked to verify the site for the work prior to quoting their rates.
- 2. Cost of tender document should be drawn in favour of **State Health Society, Assam,** payable at **Guwahati**in theform of Pay Order/Demand Draft.
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of FDR/CDR/TDR and drawn infavourof the **State Health Society, Assam,** payable at **Guwahati**.
- 4. The Contractor/bidder must be registered with the ElectronicTendering System (ETS) of the Govt.ofAssam, website: (http/assamtenders.gov.in). Contractors/Bidders can download documents free of cost. Contractors/Biddershave tonecessarily down load the bidding document from the ETS using their own ID(Digital Signature Certificate). Bid documentsnot procured (downloaded) through the ETS/not using the contractor's own user ID will be considered invalidand summarilyrejected. Contractors submitting bids online have to submit copy of the documents oftechnical bidmanually along with cost of tender document before the expiry of the sequence 'Online Bid Submission 'date and time as mentioned in the tender schedule.
