**CORRIGENDUM NO.1**  
**e-TENDER FOR ENTERING INTO RATE CONTRACT FOR PROCUREMENT OF**  
**MANNEQUINS FOR SKILL LAB**

This has reference to the e-tender No: NHM / PROC / SKILL LAB ITEMS / 3680/ 2018-19/ 4506 Date: 22/5/2018 for entering into rate contract for "Supply of Mannequins for Skill Lab". The following amendment and clarification may be taken note of prior to submission of bids.

**1. Sub-Clause C of Clause 3 "Eligibility Criteria" is amended to read as follows:**

Manufacturer should have ISO 9001:2008 or EMC Directive: 2004/108/EC certificate for quality standard.

**2. Sub-Clause D of Clause 3 "Eligibility Criteria" is amended to read as follows:**

Bidder shall have experience in supply of similar items viz mannequins/ Simulators & Training Models in any 03 (three) of the past 5 (five) financial years and the total value of order for such items awarded by Govt. Organization during any 03 (three) of the past 5 (five) financial years 2012-13, 2013-14, 2014-15, 2015-16 and 2016-17 shall not be less than Rs.5.60 Lakhs. The turnover from such orders/agreements shall be given through a certificate from the Chartered Accountant as given in Annexure IV.

**3. Sub-Clause J of Clause 3 "Eligibility Criteria" is amended to read as follows:**

**Annual Turnover**

Annual turnover statement for past 3 years i.e. 2014-15,2015-16 and 2016-17 in the format given in **Annexure-III A and Annexure-III B** certified by the Auditor/Chartered Accountant. The certificate of Auditor/Chartered Accountant must be supported by attested copies of "Profit & Loss Statement" and "Balance sheet" of last three financial years. It is to be noted that such statement of both the bidder and the manufacturer (in case the bidder is not a manufacturer) must be submitted.

However in case if the manufacturer is an overseas manufacturer, such statement of only the bidder, if submitted, will be acceptable.

**4. Sub-Clause K of Clause 3 "Execution of similar contracts of Bidder:" is amended to read as follows:**

Details of supplies of similar items made during any three of the last 5 financial years with summary of Purchase Orders and Performance Certificates issued by clients in the specified format (Refer **Annexure IV**). Items supplied to Govt. institutions and to programs sponsored by WHO, UNICEF etc., if any, should be highlighted.

All other terms and conditions of the tender referred to above shall remain unchanged. The last date of bid submission is extended to 26/06/2018 up to 2:00 PM. Bids will be opened on the same day at 4:00 PM
