This is with reference to TENDER NO: <u>No: AMSCL-17/PROC/WALK IN COOLER/17-18</u>/54-P, <u>Date:21-05-2018</u>for **"SUPPLY & INSTALLATION OF WALK IN COOLER"**.

Some amendments are incorporated which must be considered prior to submission of the Tender.

## 1. ELIGIBILITY CRITERIA

- <u>a.</u> <u>Pt. No. D:</u> To ensure certification for quality standard **USFDA/CE/ BIS** need to be produced by the manufacturing company in the bid.
- b. Pt. No. D: ISO 13485:2003 and also IEC 60601/IS-13450 is hereby removed as eligibility criteria and may not require.
- <u>c.</u> <u>a new clause Pt. No. (G)</u>: is being incorporated in the bid to be submitted by the manufacturer. Now to ensure Occupational Health and Safety Standard, the OHSAS Certificate of the manufacturer should be submitted along with the bid document.

## 2. TECHNO-COMMERCIAL BID - COVER "A"

## I) PT. NO. B : Earnest Money Deposit (EMD) : may be read as

Earnest Money Deposit amounting to **Rs.12.00 Lakhs (Rupees Twelve Lakhs)** only in the form of Demand Draft/Banker's Cheque favoring "**ASSAM MEDICAL SERVICE**". BG format will be as per standard format of Nationalized bank.

3. <u>Tender Condition Pt. No. 8 "VALIDITY OF BID"</u>: may be read as

Bids shall remain valid for acceptance for a period of **180 days** after opening of Technical Bid i.e. Cover 'A'. Bids with shorter validity shall be rejected. Purchaser may solicit bidders consent to an extension of validity period. A bidder may refuse extension request without forfeiting the EMD.

4. <u>Tender Condition Pt. No 16 "SUPPLY & SERVICE CONDITIONS" Pt. No. E "Delivery</u> <u>Period"</u> may be read as

The supply should be completed within 60 (days) for 27 Districts Drug Ware Houses.

No. E "Delivery</u> <u>Point/Destination"</u> may be read as The items shall be delivered & installed at the 27 Districts Drug Ware Houses of the state of Assam as per the list furnished along with the order or according to instructions given separately with reference to the order.
