Sealed quotations affixing non refundable court fee stamp of Rs. 8.25 is hereby invited from the intending firm /contractor authorized for carrying out the "Supply, Installation, Commissioning and Testing of Solar Power Plant of 5KW Capacity with 3 years CAMC at Amarpur PHC in Tinsukia District under NHM, Assam" as per following specification and terms and conditions for.

(A) The following documents are to be duly enclosed with the quotation.

- 1. PAN No. and GST. with copy.
- 2. Experience certificate of similar nature works taken up during last 5(five) years.
- 3. The rate quoted shall include all statutory taxes as per current Govt. rules in the state and including transportation.
- 4.The bidder/firm are required to submit authorization/ Permission License/ Certificate of Govt for supply & installation of Solar Plant.
- 5. The rate should be quoted both in figure and words separately.
- 6. Firm registration certificate.
- 7. Service Tax Registration.

(B) ELIGIBILITY

- 1. The bidder shall be an accredited Channel Partner of MNRE engaged as manufacturer/supplier of Solar Photo Voltaic Systems in India. MNRE certificate to be furnished.
- 2.The bidder must have designed, supplied, tested, erected and commissioned solar power plant with minimum capacity of 50 KW (cumulative) in the range of 10 KW and above and which is/are in successful operation on the date of bid opening.
- 3. The bidder should have Average Annual Turnover of Rs 2.00 Crores or more during the last three financial year's i.e. 2014-15, 2015-16 and 2016-17.
