1. **Sub Clause B of Clause 3 “ Eligibility Criteria” is amended to read as follows:**

Manufacturer/ Bidder should have manufacturing and marketing experience of Salt Testing Kit for minimum of 2 years in the last five financial years 2013-14, 2014-15, 2015-16, 2016-17 & 2017-18. The same should be supported by the copies of the Purchase Orders.

2. **Sub Clause K of Clause 5 “ Techno Commercial Bid” is amended to read as follows:**

Manufacturer/ Bidder should have manufacturing and marketing experience of Salt Testing Kit for minimum of 2 years in the last five financial years 2013-14, 2014-15, 2015-16, 2016-17 & 2017-18. The turn over from such orders shall be given through a certificate from the Chartered Accountant as given in Annexure IV. The same should be supported by the copies of the Purchase Orders.
