This is with reference to TENDER REFERENCE NO: NHM-18011/5/2018-PROC-NHM/207-P, DATE: 28-11-2018 for supply of drugs from Local SSI/MSEs of the state of Assam.

The following amendments in the tender may be taken note of prior to submission of bids.

1. **Clause 3** Pt. no (b) "**ELIGIBILITY CRITERIA**" is amended to read as : Average Annual turnover 1 Cr during the last five FY years i.e 2012-13, 2013-14, 2014-15, 2015-16 & 2016-17 in the format given in Annexure-III certified by the Auditor/Chartered Accountant must be submitted by the bidder. The certificate of Auditor/Chartered Accountant must be accompanied by attested/notarized copies of audited "**Profit & Loss Statement**" and "**Balance Sheet**" of last five FY years i.e 2012-13, 2013-14, 2014-15, 2015-16 & 2016-17 also to be submitted with the bid.
2. **Clause 4** "**TECHNO-COMMERCIAL BID**" - **COVER "A" Pt. No. (I)** is amended to read as Annual turnover statement from sales of Drugs for last five Financial years i.e. 2012-13, 2013-14, 2014-15, 2015-16 & 2016-17 in the format given in Annexure-III certified by the Auditor/Chartered Accountant. The certificate of Auditor/Chartered Accountant must be accompanied by attested/notarized copies of audited "**Profit & Loss Statement**" and "**Balance Sheet**" of past five financial years (2012-13, 2013-14, 2014-15, 2015-16 & 2016-17).

**Income Tax Return Certificate** of the said year also need to be furnished.

**Explanatory Note**:-The merger / amalgamation / transfer of business / transfer of assets of a firm affect the bid condition relating to 'Turnover' in preceding years. The eligibility of a bidder in this regard shall be ascertained by the Purchase Committee on the basis of the above stated agreement / BOD resolution / CA certificate or any other document(s) annexed with the tender documents and the decision of Purchase Committee shall be final. The amount shown as Turnover in the tender should be the amount as per VAT Act / other Acts and necessary documents / certificates shall be annexed with tender documents and accordingly eligibility of a bidder in this regard shall be ascertained by the Purchase

Committee.
