2. GENERAL CONDITIONS.

- a) The bid document may be obtained from Office of the Mission Director on payment of bid document fee of Rs. 2,000/- by DD in favour of State Health Society, Assam or can be downloaded from the official website https://nhm.assam.gov.in/. The bidder downloading the bid document from the website is required to deposit Rs 2000/-(non-refundable) as tender document fee, in the form of Demand Draft in favour of "State Health Society, Assam" payable at Guwahati while submitting the bid. Tenders without the fee Rs 2,000/- will not be accepted.
- b) All bids must be accompanied by Earnest Money Deposit (EMD) as specified in the relevant clause of the bid document. The EMD of the successful bidder shall be retained till

completion of the bidding process but shall not carry any interest. If the successful bidder fails to execute the agreement within the specified time, or withdraws his bid within the validity of the bid, the EMD shall be forfeited. The EMD of the unsuccessful bidders will be returned within 30 days after the finalization of the bid. The EMD of the unsuccessful bidders will be returned within 60 days after the finalization of the tender and submission of performance security deposit amounting to 5% of the order value.

- c) Bidders that are currently registered and valid till the last date of submission of the tender document or eligible Micro and Small Enterprises (MSEs) are exempt from payment of Tender fee and Earnest Money Deposit (EMD). However, the bidder will have to submit a certified copy of its valid registration details.
- d) Bids will be opened in the presence of bidders or their authorized representatives on the specified date and time as stipulated in the bid document.
- e) At any time prior to the date of submission of bid, the Tender Inviting Authority may, for any reason, whether on his own initiative or in response to a clarification requested by a prospective bidder, modify the tender documents by an amendment. All prospective bidders who have received the bid document will be notified of the amendment and that will be binding on them. In order to provide reasonable time to take the amendment into account in preparing their bid, the Tender Inviting Authority may at its discretion, extend the date and time for submission of bids.
- f) Interested eligible bidders, if they so desire, may obtain further information from the office of the Tender Inviting Authority.
- g) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such proposal will be rejected and will not be considered for further process. Excuses like typographic error will not be entertained.
- h) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept on holiday or blacklisted apart from other penal actions as deemed fit by National Health Mission, Assam.

3. AFTER SALES WARRENTY SERVICE CONDITIONS:

a) National Health Mission will register Service Calls only at the local vendor/company office or their authorized dealer / agent / service centre by telephone or e-mail. At least three local active service numbers & one e-mail ID to be provided.

- b) Calls to be attended within Three hour (3 hrs) of the Call registered.
- c) Maximum downtime for Server should not more than 48 hrs.
- d) During the entire warranty period, defective parts to be replaced only by new equivalent (same make & model as the original) parts.
- e) After completing one service call at the user location, proper Service Report to be filled
 & signed.
- f) Quarterly progress report must be submitted to the Mission Director, National Health Mission, Assam along with call log details (user detail, call log no, call log time, call closed time, details of service provided) which should be supported by copy of service reports duly signed by the user. Quarterly report should be submitted within 15th day of the month ending the quarter. Penalty @Rs. 200/- per day will be imposed for delay in submission of quarterly report. If the vendor failed to submit quarterly report for more than six months after crossing due date, then the security deposit will be forfeited and other punitive action like blacklisting of the vendor will be considered. In that case, first show cause notice will be issued to the vendor and if satisfactory reply not received within 7 days, then punitive actions mentioned above will be imposed.
- g) Following points will be marked as Unsatisfactory After Sales Service, if:
 - a. A Call is not attended within 24 hour of the Call logged.
 - b. Server is down for more than 48 hours.
 - c. Technical incompetence of the Service Personal.
 - d. Improper / illegitimate activities by the Service Personal.
- h) Penalty will be imposed if the After Sales Service of the vendor is not satisfactory during the warranty period.
- i) Penalty amount will be deducted during release of security deposit.
- j) Penalty will be imposed as per the following list, if the After Sales Service of the vendor is not satisfactory:

k) Penalty value will be calculated on quarterly basis. If the total penalty value crossed the security deposit amount, then the security deposit will be forfeited and other punitive action like blacklisting of the vendor will be considered.

4. TECHNICAL BID- COVER "A"

5. PRICE BID - COVER "B"

The bidder shall put the duly signed Price Bid in a sealed cover Super scribed as "PRICE BID COVER "B" SHORT TENDER NOTICE FOR SUPPLY AND INSTALLATION OF ONE RACK SERVER ALONG WITH WINDOWS OPERATING SYSTEM" and addressed to the Mission Director, National Health Mission, Saikia Commercial Complex, Srinagar Path, Christianbasti, G.S Road, Guwahati-781005, Assam.

- a) Signature and Seal on each page:
 - Each page of the price bid should be duly signed by the bidder affixing the office seal.

b) Rates quoted:

- The bidder shall submit the Price Bid (Cover B) in the format as mentioned below only in the official letter head.
- The rates quoted shall be inclusive of all taxes and any other charges.
- Prices to be quoted on FOR DESTINATION basis showing Basic Price and Tax separately in the Price Bid.
- The quoted price shall also be inclusive of cost of supply, installation and commissioning of the equipments at the Destination.
- In case of error in calculation of "Net Unit Cost": "Net Unit Cost" calculated based on "Basic Unit Price" and Tax (%) shall be considered for final evaluation.

6. COVER FOR TECHNICAL BID & PRICE BID

The two separately sealed covers Technical Bid (Cover "A") and Price Bid (Cover "B") shall be placed together inside another cover which shall be sealed and super scribed as "SHORT TENDER NOTICE FOR SUPPLY AND INSTALLATION OF ONE RACK SERVER ALONG WITH WINDOWS OPERATING SYSTEM" and addressed to the Mission Director, National Health Mission, Saikia Commercial Complex, Srinagar Path, Christianbasti, G.S Road, Guwahati-781005, Assam.

7. OPENING OF COVER "A" AND COVER "B" OF TENDER

- a. Bidders or their authorized representatives are entitled to be present on the date and time of opening of Technical Bid Cover "A".
- b. Only those bidders whose Technical Bids are found acceptable after technical and commercial evaluation will be invited to be present at the date and time of opening of Price Bid Cover "B". The price bids of bidders not found technically qualified will not be opened.

8. VALIDITY OF BID:

Bids shall remain valid for acceptance for a period of 90 days after opening of Technical Bid i.e. Cover 'A'. Bids with shorter validity shall be rejected. Tender Inviting Authority may solicit bidders consent for an extension of validity period. A bidder may refuse extension request without forfeiting their EMD.

9. VALIDITY OF OFFER OF SUCCESSFUL BIDDER:

The validity of offer of the successful bidder shall be at least two years from the date of finalization of the order and the successful bidder will be bound to supply the items at agreed rates and terms during this period.

10. ACCEPTANCE OF TENDER

(i) Tender Evaluation

Tenders will be evaluated with reference to various criteria of technical bid and thereafter on the basis of the price per unit (landed price per unit) for determining the

L1 (Lowest) Rate from amongst those qualifying the technical bid stage. Conditional discounts shall not be taken into account for price comparison.

(ii) Right to Reject Tender

Tender Inviting Authority reserves the right to accept the tender or to reject the tender for all items or for any one or more of the items tendered at any point of time without assigning any reason.

(iii) Tender Acceptance

The acceptance of the tenders will be communicated to the successful bidder in writing.

11. AGREEMENT

The successful bidder shall execute an agreement for three years on a non-judicial stamp paper of the value of Rs 100 (stamp duty to be paid by the bidder) within 10 days from the date of the intimation from Tender Inviting Authority informing that his tender has been accepted or within 10 days from the date of issue of order.

12. SECURITY DEPOSIT

The successful bidder(based on performance of warranty period), within 10 days of signing of the agreement, shall be required to submit Security Deposit of 5% of the order value in the form of bank guarantee from any Indian nationalized bank in favour of "State Health Society, Assam" valid for a period of **Four years** from the date of order. However, if the supplier fails to execute the order or fails to perform the services as per agreement, in addition to other penal actions, the bank guarantee shall be encashed and the amount will be forfeited and the bidder will be prohibited to participate in any tender under NHM for next 5 years.

If the supplier fails to provide onsite support during the warranty period, the bank guarantee shall be encashed and the amount will be forfeited.

13. NON ASSIGNMENT OR SUB-LETTING

The bidder shall not, at any time, assign, sub-let or make over the contract or the benefit thereof or any part thereof to any person or persons, whatsoever.

14. COMMUNICATION

All notices or communications relating to or arising out of the agreement or any of the terms thereof shall be considered duly served on or given to the bidder if delivered to him or left at his premises, places of business or abode.

15. ANNULMENT OF AWARD, FORFEITURE OF SECURITY DEPOSIT & FRESH AWARD

Failure of the successful bidder to comply with the requirements of signing of agreement and / or submission of security deposit within the time schedule as stipulated above shall constitute sufficient grounds for the annulment of the award and forfeiture of the bid security/EMD. Under such a situation, the proposal may be reviewed for award of the contract on the next lowest evaluated technically qualified bidder or go for a fresh bid depending on the circumstance. In case it is decided to go for the next lowest bidder, negotiation may be considered to bring down their price nearer to the originally evaluated lowest bid.

16. SUPPLY CONDITIONS

a. Specifications and Quality

The items supplied by the successful bidder shall be of the best quality and shall comply with specifications, stipulations and conditions specified at **Annexure -A.**

b. Delivery Period

The items are to be delivered, installed and commissioned at Office of the Mission Director, National Health Mission, Saikia Commercial Complex, Srinagar Path, Christianbasti, G.S Road, Guwahati-781005, Assam within **20 days** from the date of receipt of the order.

c. Warranty

Minimum 3 years Warranty (with warranty certificate) from the date of installation.

d. Penalty for Delayed Delivery

i. In case there is delay in delivery beyond the stipulated period as mentioned in the purchase order, there shall be reduction in price @ 0.5 per cent of the value of the

delayed goods per day of delay or part thereof subject to a maximum of 10 per cent of the total order value

ii. Once the maximum price reduction is reached, termination of the contract may be considered. Non-compliance of the contract provisions shall make the successful bidder liable to be disqualified to participate in any tender for the next 5 years, in addition to forfeiture of Security Deposit and other penal actions.

17. JURISDICTION OF COURT

Legal proceedings if any shall be subject to Gauhati High Court, Guwahati, Assam jurisdiction only.

18. PAYMENT TERMS

- a) No advance payments will be made.
- b) Payment will be 100% after receipt, installation and successful commissioning of equipments at destination.
- c) Bill should be submitted in triplicate. Following documents should be furnished along with the bill:
 - (i) Original Delivery Challan must be submitted along with the Bill.
 - (ii) Installation report should be submitted for each item.
 - (iii) Warranty certificate of the OEM for the item.
- d) Payment will not be released without Security Deposit of 5% of the Total Order value in the form of Bank Guarantee (BG) from any Indian Scheduled-A Bank in favour of "STATE HEALTH SOCIETY, ASSAM" valid for a period of 4 Years from the date of supply.

Incomplete application form or application submitted by organizations that do not fulfill eligible criteria will be rejected.
