**Eligibility Criteria:**

1.
  - a. Registered APWD (Bldg) Class I-(A),I(B),I(C) & Class II / CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking
  - b. Contractors having completed works in any one year during last five years at least one similar nature of completed work value not less than 30% of the proposed project cost.
  - c. The contractor who was earlier allotted any NRHM works by APWD (B), Assam or by NRHM and could not complete the work in all respect **in time** will not be **ELIGIBLE** to participate in the bidding process.
  - d. The contractor & to whom extension of time was granted from NRHM imposing penalty will also not be **ELIGIBLE** to participate in the bidding process.
2. Cost of tender document should be drawn in favour of **State Health Society, Assam**, payable at **Guwahati** in the form of Pay Order/Demand Draft.
3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the **State Health Society, Assam**, payable at **Guwahati**.
4. Date for issuing of Bid Document: **20-05-2013 to 21-05-2013 during working hours.**
5. Last date and time of submission of Bid: **21-05-2013 at 14-00 hrs**
  - a. **The bids will be opened at 15.30 hrs of the same days as mentioned above.**
