CORRIGENDUM NO.1

<u>e-TENDER FOR ENTERING INTO RATE CONTRACT cum EMPANELLMENT OF</u> MANUFACTURERS TO SUPPLY OF ESSENTIAL SURGICAL, CONSUMABLES, CHEMICALS

This is with reference to e-Tender No. NHM-18011/14/2018-PROC-NHM/74-P, DATE: 05/01/2019 for entering into rate contract cum EMPANELLMENT OF MANUFACTURERS TO SUPPLY OF ESSENTIAL SURGICAL, CONSUMABLES, CHEMICALS

The following amendments in the tender may be taken note of prior to submission of bids.

1. Clause3 "ELIGIBILITY CRITERIA":

A new point is incorporated as pt. (l): Bidder should declare the production capacity and also separable capacity for the state of Assam and the separable Capacity should not be less than 50% of the estimated requirement mentioned in the tender document. If the separable capacity for the state of Assam is less than 50% of the estimated requirement in the tender, the same bid will be declared as to be rejected.

2. <u>Clause 4TECHNO-COMMERCIAL BID - COVER "A" PT. NO. "H" NON-CONVICTION CERTIFICATE</u>

Attested/notarized copy of Non-conviction Certificate issued by the Competent Authority either from the Inspector of Industry/Inspector of Factory/Inspector of Food & Drug/ Officer in Charge of the Police station where the manufacturing unit is situated/ Circle officer/Taluka Magistrate/ District Magistrate/Deputy Commissioner/ Addl. Deputy Commissioner/ District Administration of the concerned district/State or Drug Control Authority certifying that the firm has not been convicted in the last three years i.e 2014-15, 2015-16, 2016-17, must be submitted with the bid.

3. Clause4 "TECHNO-COMMERCIAL BID - COVER A"

A new point is incorporated as pt. (W) "<u>DECLARATION ON MANUFACTURING CAPACITY & SPARABLE CAPACITY</u>":Undertaking on MANUFACTURING FACLITY & SPARABLE CAPACITY in **Non-judicial stamp paper** must be submitted with the Bid as per format at **Annexure-VII-B**

4.Clause 11 "ACCEPTANCE OF TENDER"-A "Tender Evaluation"

Tenders will be evaluated with reference to technical and commercial parameters to determine the technically qualified bidders for all items.

Price Bids of technically qualified bidders will be evaluated with reference to the

quoted price (landed price) of each item to determine the L-1 (Lowest) price. Conditional discounts shall not be taken into account for price comparison.

- a) After the conclusion of Price Bid opening, the lowest offer of the Bidder, if required will be considered fornegotiations, and ratearrived after negotiations will be L-1 rate and L-1 supplier for an item of drugs/medicines for which the Bid has been invited.
- b) The Bidder who has been declared as L-1 supplier for certain item or items of drugs/medicines shall execute necessary agreement for the supply of the Bided quantity of such drugs/medicines as specified in the Bid document on depositing the required amount as performance security and on execution of the agreement, such Bidder is eligible for the placement of purchaser orders. Moreover, purchase order can be placed after the issue ofletter of acceptance, pending the execution of agreement and issuance of rate contract for anitem.
- c) Orders will be placed periodically during rate contract period based onthe NHM, Assam requirement to the firms approved for rate contract as per aboveclause no. 3 above (Price Preference/PurchasePreference).
- d) NHM, Assam may also place purchase orders withthe Matched L-1 bidder. For such issue L-2 will get the first scope to match rates of L-1 and in case L-2 will not ready to negotiate at the price quoted by L-1 than L-3.

 Rest the tender inviting Authority will decide to go with L-4, L-5etcif L-2 & L-3 both will not ready to negotiate at the price quoted by L-1
- e) However, the label should possess the required logogram, and the price should not appear on the label. Label must contain the *PHARMACOPOEIA details if the item/items is covered under Drugs& Cosmetic Act.*
- f) The rates quoted and accepted will be binding on the Bidder during validity period of the bid and any increase in the price (except increase due to Excise Duty or any other statutory taxes) will notbe entertained.
- g) No Bidder shall be allowed at any time on any ground, whatsoever it may be, to claim revision or modification in the rates quoted by him after last date fixed for receipt of bid. Representation to make correction in the Bid documents on the ground of Clerical error, typographical error, etc., committed by the Bidders in the Bids shall not be entertained after submission of the Bids. Conditions such as "SUBJECT TO AVAILABILITY" "SUPPLIES WILL BE MADE AS AND WHEN SUPPLIES ARE RECEIVED" etc., will not be entertained under any circumstances and the Bids of those who have given such conditions shall be treated as incomplete and accordingly the Bid will be rejected.
 - h) The rates should be quoted only for the composition stated in the Bid.
 - i) Supplies should bemade directly by the bidder and not through any other agency.
