CORRIGENDUM NO.1

For Operation and Management of Free "Adarani – Pickup & Drop Back Services" to mothers and neonates as part of Janani Shishu Suraksha Karyakram (JSSK) Scheme in Assam

This has reference to the e-tender No: NHM/24011/8/2018-ReferalTransport—NHM/28391 Dated: 02/02/2019 invited from eligible Service Providers willing to work on PPP Mode for operation and maintenance of "Free Adarani —Pickup and Drop Back Services to Mothers and Neonates."The following amendment and clarification may be taken note of prior to submission of bids.

1. Sub-clause 1.6.2 of Clause 1.6 "ELIGIBILITY CRITERIA" is amended to read as follows:

The Bidder should have a minimum three years of business experience and at least one (1) year in successfully handling similar services in public sector with a minimum of 200 vehicles as of 31/03/2018. Performance Statement witnessing the same certified through Auditor/Authorized Supervising Entity must be submitted as per Annexure III of this RFP document. Attested copy of Agreements/Work Orders and Performance Certificate from the Authority(s) of the ongoing/complete project must be submitted along with the Technical Proposal.

2. Sub-clause 1.6.3 of Clause 1.6 "ELIGIBILITY CRITERIA" is amended to read as follows:

Average Annual Turnover of the bidder in the last three financial years i.e. 2015-16, 2016-17 and 2017-18 should not be less than **Rs.500.00 Lakhs.** The average annual turnover certificate as issued by the Auditor/Chartered Accountant should be submitted in the format enclosed as **Annexure II** of this RFP document. The Certificate must be accompanied by attested copies of audited Statement of Accounts of last three financial years (i.e. 2015-16, 2016-17 and 2017-18).

3. Sub-clause 1.6.4 of Clause 1.6 "ELIGIBILITY CRITERIA" is amended to read as follows:

Experience in call centre based vehicle management and operation with GIS based GPRS integrated vehicle monitoring system. The bidder has to produce supporting to this effects including certificate from the Client or the Authority

4. <u>Sub-clause 1.8.9 of Clause 1.8 "TECHNO-COMMERCIAL BID - COVER "A""is amended to read as</u> follows:

Experience in Similar Contracts of the Bidder: Performance Statement witnessing the experience of running similar service with not less than 200 vehicles for at least one year as of 31/03/2018. Certified by the Auditor/Chartered Accountant/Authorized Supervising Entity must be submitted as per Annexure III of this RFP document. Attested copy of Agreements/ Work Orders and Performance Certificate from the Authority(s) of the ongoing/ complete project must be

furnished along with the certificate. Bidder has to furnish evidence in support of its experience in call centre based vehicle management and operation with GIS based GPRS integrated vehicle monitoring system (as mentioned in Clause no 1.6.4 above).

5. Sub-clause 1.10.5 of Clause 1.10 "TECHNICAL EVALUATION" is amended to read as below:

The Applicant (Bidder) who fails to score a minimum of **60 marks out of 100** marks in the technical evaluation shall not qualify for further evaluation. The Financial Bid for only technically qualified Applicants (Bidders) shall be opened for evaluation and the Applicant having lowest financial bid shall be awarded the contract.

6. Sub-clause 3.3.2 of Clause 3.3 "RESPONSIBILITY OF THE SERVICE PROVIDER" is amended to read as below:

The Service Provider should ensure that the vehicle should not be older than 1(one) year from the date of actual induction/operation. The vehicle should be comfortable **two wheel drive SUV category** capable of taking at least six nos of passengers at a time.

7. Sub-clause 3.5.4 of Clause 3.5 "INVESTMENT AND OWNERSHIP" is amended to read as below:

Schedule of implementation: Adarani Drop Back Service is currently operational with 235 nos. of Vehicles in all the districts of Assam .The winning bidder has to start and operationalize the services across all districts within **75 Days** from the date of signing of agreement without any interruptions to the current operations. Government shall handover all the assets including IT and hardware infrastructure to the winning bidder.

8. Off Roading Definition under Clause 1.23 is amended and clarified to read as follows:

If a vehicle remaining off road continues for more than 2 hours upto 6 hours during duty time then it shall be considered as 0.5 days of offroad and if the vehicle remain off road continuously for more than 6 hours during duty period then it shall be treated a 1 day off road.
