SHORT TENDER NOTICE
(NATIONAL COMPETITIVE BIDDING)

Tenders in two Bid System (Technical Bid & Price Bid) affixing Court Fee Stamp of Rs 8.25 (or IPO of Rs 10.00 in favour of "State Health Society, Assam" for bidders located outside Assam) are invited from manufacturers/authorized distributor & dealer for supply of the "Psychotropic Drugs" on an **urgent basis** to 26 districts in the State of Assam.

A. Important dates:

1. Tender submission start date : 06/03/2019 from 2.00 pm.
2. Tender submission End date : 12/03/2019 up to 2.00 pm.
3. Tender opening date : 12/03/2019 at 3.00 pm.
4. Tender opening place : O/O the Mission Director, National Health Mission, Assam.

B. Important Notes:- (Supplies shall be subject to the following terms & conditions):

1. **Name of drugs and required quantity:** Mentioned at pt. D for the state of Assam.
2. **Manufacturers as well as authorized Distributors/Dealers (with copy of Authorization against the said tender) both are allowed to participate in the Bid.**
3. The selected bidder (or) bidders has to supply the ordered quantity as stated below in pt. D and the total quantity must be supplied within 30 days against the declaration submitted with the technical bid to the State Ware House, Guwahati from the issue of the purchase order.
4. The supplied Drugs (covered under Drugs and Cosmetics Act 1940) should have shelf life period as prescribed in the Drugs and Cosmetics Act 1940 and rules there under. There should have shelf-life of minimum 1 year from the date of supply.
5. If a supplier fails to execute successive order within the stipulated time frame, in full, that firm will be liable to debarred for the particular product, for a period of 1 year.
6. Any Bidder has been blacklisted or debarred by any State/UT Government /Central Government / Govt. Drug Procurement Agencies due to quality failure or fraudulent/illegal practices of the drugs supplied will not be considered.
7. The successful Bidder shall execute an agreement on non-judicial stamp paper of value Rs 100/- (stamp duty to be paid by the Bidder) within 5 working days from the date of issuing of Supply order. The successful bidder shall submit Security Deposit of 5 % of the order value in the form of Bank Guarantee from any Indian Schedule Bank in favour of "State Health Society, Assam" within 10 working days from date of issuing of Purchase Order by Tender Inviting Authority. Such Bank Guarantee shall be valid for a period of 1 year from the date of Purchase Order. If the supplier fails

- Guarantee shall be valid for a period of 1 year from the date of Purchase Order. If the supplier fails to execute the order or fails to perform the services as per agreement, actions, the Bank Guarantee shall be encashed and the amount will be forfeited.
8. The supply should preferably in Generic name but in view of emergency requirement in the field, brand name will also be accepted but the MRP should be stroked out from the pack to be supplied.
9. The supply should be accompanied with either in house batch wise test analysis report or the batch-analytical test reports from NABL Lab before the commencement of supply to obtain the Dispatch Clearance Certificate from the NHM-Authority but to get the payment against supply the batch wise test analysis report from NABL Lab must be submitted along with bills and receipt-challan copies.
10. Payment will be made within 30 days from receipt and acceptance of materials at destination against submission of bill & receipted challan (in triplicate) with stock entry details, and test certificate of batches supplied. In case there is delay in delivery beyond the stipulated period as mentioned in the purchase order, there shall be penal deduction @ 0.5% of the value of delayed goods per day of delay or part thereof subject to a maximum of 10% of the total order value. Once the maximum price reduction is reached, termination of the contract may be considered. Non-performance of the contract provisions shall make the successful bidder will be liable to disqualification for the particular product, for a period of 1 year from NHM Assam tender, in addition to forfeiture of Security Deposit.
- C. The quotation should be accompanied by attested copies of the following: **MARKED AS COVER A: TECHNICAL BID** which will be also considered as **Eligible Criteria to be a technically responsive bidder**:
- (i) **Certification of WHO-GMP: (without the same the bid will be considered as incomplete)**
Attested/notarized copy of **Valid WHO-GMP** certificate of the manufacturer must be submitted with the tender. Original certificate should be produced if demanded for verification.
- (ii) **Manufacturing License: (without the same the bid will be considered as incomplete)**
Attested/notarized copy **Valid Manufacturing License** of the quoted drugs must be submitted along with the Bid. Original license should be produced if demanded for verification.
- (iii) **Trade as well Drug License (without the same the bid will be considered as incomplete)**: If the bidder will be authorized distributor/dealer of the bidding manufacturer, the Valid Trade License & valid Drug License (**For selling of Psychotropic Drugs**) from the Competent Authority must be submitted.
- (iv) **Product permission (without the same the bid will be considered as incomplete)**:
Product permission from Drug Control Authority of the products must be submitted with the technical document.
- (v) **Execution of Similar Contract (without the same the bid will be considered as incomplete)**:
Supply order copies in the name of the manufacturer or distributor/dealer from Govt. organization (minimum three) executed during the last 3 FY 2016-17, 2017-18, 2018-19 (Till February 2019) for drugs must be submitted with the bid.
- (vi) **Annual Turnover (without the same the bid will be considered as incomplete)**: The manufacturer must have Average Annual Turnover 20.00 Crs. (twenty crores) as a manufacturer of Drugs during the last 3 FY 2015-16, 2016-17, 2017-18 & certified copy on Annual Turnover from Chartered Accountant must be submitted with the Bid.

If the bidder is an **authorized distributor or dealer**, the Average Annual Turnover should be 2.00 Crs. (two corers) as a distributor/ dealer of Drugs during the last 3 FY 2015-16, 2016-17, 2017-18 & certified copy on Annual Turnover from Chartered Accountant must be submitted with the Bid.

In case the bidder is an authorized distributor/dealer, it has to submit the turnover certificate of manufacturer having not less than Rs. 20.00 Crs along with its own turnover certificate of Rs. 2.00 Crs from Chartered Accountant must be submitted with the Bid.
