Eligibility Criteria:-

- 1.(a) Registered APWD (Bldg) ClassI-(A)/I-(B)/I(C) and class-II/CPWD/Reputed Construction Company/Agency registered under Govt./Public Sector undertaking.
- (b) Contractor must have satisfactory completed:-
 - i). Four similar works, each of value not less than 25% of the estimated cost put on tender OR.
 - ii). Three similar works, each of value not less than 40% of the estimated cost put on tender OR
 - iii) Two similar works, each of value not less than 50% of the estimated cost put- on tender or
 - iv). One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited.
- (c) Contractor must have achieved average Annual Turnover of at least 30% of estimated cost during last 3 years ending 31st March of the previous Financial Year.
- (d) The Contractor having PAN Card/GST Registration/Labour License/registration under EPF & MPAct, 1952 etc. are eligible to participate in the bid process.

Other conditions:-

- (i) In case the evaluated bid amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital Building projects on earlier occasion.
- (ii) The intended bidders are asked to verify the site for the work prior to quoting their rates.
- (iii) **No contractor will bid for or will be considered for allotment of work for package/packages outside the district. This means bid will be confined for the packages within the district concerned only. For ex: A bidder can bid for Pkg-1 or Pkg-2 or Pkg-3 or all 3 (three) from Jorhat District but not from any other district. Similar is the case with other districts.**
2. Cost of tender document should be drawn in favour of **State Health Society, Assam**, payable at **Guwahati** in the form of Pay Order/Demand Draft.
3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of FDR/CDR/TDR and drawn in favour of the State Health Society, Assam, payable at Guwahati.
4. The Contractor/ bidder must be registered with the Electronic Tendering System (ETS) of the Govt. of Assam (**website <http://assamtenders.gov.in>**). Contractors/ Bidders can download documents free of cost. Contractors/ Bidders have to necessarily download the bidding document from the ETS using their own ID (Digital Signature Certificate). Bid documents not procured (downloaded) through the ETS/not using the contractor's own user ID will be considered invalid and summarily rejected. Contractors submitting bids online have to submit copy of the documents of technical bid required to be submitted manually along with cost of tender document before the expiry of the sequence 'Online Bid Submission' date and time as mentioned in the tender schedule. Bid will be rejected/ cancelled if Financial Bid submitted off-line/hard copy.
