**SHORT NOTICE INVITING TENDER (SNIT)**

The Office of the Mission Director, National Health Mission, Assam invites bid for the works under NHM in single bid system (in F2 form) affixing court fee stamp of Rs.8.25 (Rupees Eight and Twenty Five Paisa) only for the works as detailed below: -

1. Eligibility Criteria: -

- A. Registered APWD (Bldg) Class I-A, B, C/Class-II /CPWD Contractors /Reputed Const. Company/ Agency registered under Govt. / Public sector undertaking.
- B. Contractor must have satisfactory completed
  - I. Four similar works, each of value not less than 25% of the estimated cost put on tender or
  - II. Three similar works, each of value not less than 40% of the estimated cost put on tender or
  - III. Two similar works, each of value not less than 50% of the estimated cost put on tender or
  - IV. One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited.
- C. The Contractor having PAN Card/GST Registration/ Labour License/ registration under EPF and MP ACT 1952 Etc, are **ELIGIBLE** to participate in the bid process.
- D. Contractor must have achieved average Annual turnover of at least 30% of estimated cost during last 3 years ending 31st march of the previous financial year
- E. In case the evaluated bid amounts are equal, preference for allotment of the project will be given to the bidder who has completed Building works under NHM on earlier occasion.
- F. The intended bidders are asked to verify the site for the work prior to quoting their rates.**
- G. The intending bidders or their authorized representatives are to be present at the time of opening of Bids. Otherwise the bids will be opened in their absence and no claim will be entertained in future.
- H. Cost of tender document should be drawn in favor of **State Health Society, Assam**, payable at Guwahati in the form of Pay Order/Demand Draft.
- I. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of **Bank Guarantee/ FDR/CDR** and drawn in favor of the State Health Society, Assam, payable at Guwahati.
- J. Date of receipt of application along with cost of tender document and copies of documents as per eligibility criteria mentioned at Sl.1 (a), (b) & (c) & issue of Bid Document up to: -**12-03 2019** during working hours.
- K. Last date and time of submission of Bid: -**13-03-2019 at 14-00 hrs.**
- L. The bids will be opened at **15.30 hrs.** of the same days as mentioned above.
