Invitation of Quotations for Purchase of Motorcycle and Scooter

Sealed quotations affixing court fee stamp of Rs 8.25 in single bid system are invited from reputed manufacturers or their authorized dealers for purchase of motorcycles and scooters as per format provided below. The motorcycle and scooter brand should have good service network across Assam.

Copy of following documents should be enclosed along with the quotation:-

- Manufacturer certificate or authorized dealership certificate.
- List of authorized service centers across Assam.
- Trade License/ Registration Certificate, up to date
- VAT Registration Certificate.
- Copy of previous supply order(s) from other organizations , if any.

BID PRICE

- The purchase contract shall be for the item wise full quantity as described above, however at the time of purchase the quantity may vary depending upon actual need. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
- The quoted price shall be excluding of taxes and FOR destination Guwahati.
- The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- The prices shall be quoted in Indian Rupee only.
- Each bidder shall submit only one quotation.

VALIDITY OF QUOTATION

Quotation shall remain valid for a period not less than 1 year after the deadline date specified for submission.

PERFORMANCE SECURITY DEPOSIT

The successful bidder may be required to submit a Security Deposit @ 4% of the bid value which will be released on completion of the service agreement.

ANNULMENT OF AWARD, FORFEITURE OF SECURITY DEPOSIT & FRESH AWARD

Failure of the successful bidder to comply with the requirements of signing of contract and / or submission of performance security within the time schedule as stipulated above shall constitute sufficient grounds for annulment of the award and forfeiture of the Security Deposit Money.

Under such situation, the proposal may be reviewed for award of the contract on the next lowest evaluated technically qualified bidder or go for a fresh bid depending on the circumstances.

EVALUATION OF QUOTATIONS

The purchaser shall evaluate and compare the quotations determined to be substantially responsive which are properly signed and confirm to the terms and conditions. Tender will be evaluated item wise.

AWARDS OF CONTRACT

The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive, have after sales service network and who has offered the lowest evaluated quotation price.

Notwithstanding the above, the purchaser reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.

The bidder whose bid is accepted will be notified of the award of the contract by the purchaser prior to the expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

OTHER TERMS

1. The motorcycle/scooter brand should have good service network across Assam. At least 1-02 Service center at each District HQ of Assam or in most of the districts of Assam .
2. The specifications should match as per annexure I & II (Whichever is applicable)
3. Payment shall be made only after successful delivery of the motorcycles/scooters.
4. The purchaser reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.
5. The bidders to provide their offer latest by **2:00 PM** on **04.06.13**
