1. Point (i) under Sub Clause 1.6.2 of Clause 1.6 is amended to read as follows:

Experience in Similar Service/Work:

The Bidder should have experience of successfully booking air tickets **1200 passengers** in each of the last three financial years 2015-16, 2016-17 and 2017-18. Performance Statement witnessing the same certified by an Auditor/Legal entity/Authorized Supervising Entity must be submitted as per **Annexure III** of this RFP document. **Attested copy of Agreements/ work orders and Performance certificate from the Authorities of the ongoing/ complete project form the Govt. /Private sector must be submitted with the Technical Bid.**

2. Sub Clause 2.2.2 of Clause 2.2 is amended to read as follows:

The Bidder should have experience of successfully booking air tickets **1200 passengers** in each of the last three financial years 2015-16, 2016-17 and 2017-18. Performance Statement witnessing the same duly certified by the Auditor/Chartered Accountant must be submitted as per **Annexure III**.
