# Notice Inviting Expression of Interest from reputed Super Specialty Hospitals for entering into a MoU with the Govt. of Assam for carrying out Liver Transplant in children below 12 years of age

#### 1. Background:

The Department of Health & Family Welfare, Government of Assam has recently launched a unique Health Care Initiative that aims at extending financial assistance for specialized treatment of children below 12 years of age afflicted with some serious ailments, with priority given to children belonging to BPL families. Some of these children may need referral to suitable higher facilities outside the state for specialized treatment; while others may be treated in institutions inside the state itself in Super Specialty Departments. For both the groups, financial assistance will be offered under the Sneha Sparsha Scheme. Liver transplant is among the identified conditions under the scheme for which treatment shall be financed from the Govt of Assam. The government of Assam seeks to enter into a Memorandum of Understanding with Super Specialty Hospitals in order to carrying out Liver Transplant in children below the age of 12 years from the state of Assam.

#### 2. Credentials/performance

- i. Hospitals that have been carrying out the said treatment for a period of at least 2 years prior to the date of publication of this notice shall be eligible for applying.
- ii. The hospital is to submit the performance report for past 2 years indicating total number of Liver Transplants conducted in the Hospital (year wise) and the success rate against it.
- iii. The Hospital is to submit the list and qualification detail of specialists performing Liver Transplant in the Hospital.

#### 3. Invitation for Expression of Interest:

Expression of interest is invited from reputed Super Specialty Hospitals of India for entering into a Memorandum of Understanding with the Department of Health, Government of Assam for carrying out Liver Transplant in children below the age of 12 years from the state of Assam.

The proposals are to be submitted in two parts - "Technical Bid" and "Price Bid", with both Bids to be sealed separately but submitted together. Price Bids of only those hospitals would be considered who can establish through documentary proof in their Technical Bid their ability to carry out Liver Transplant in children along with required follow up.

Interested hospitals may submit their proposals with a package rate which should include cost of procedure, investigations, pre and post operative care and medications for initial 3 months. The rates quoted should not exceed the prevailing CGHS rates.
