CORRIGENDUM NO.1 (NATIONAL COMPETITIVE BIDDING) Two-year Rate Contract ending on 31.03.2022

This is with reference to e-Tender No. NHM/18017/37/2019-PROC-NHM/ECF-118874/16761, DATE: 30.10.19 for entering into Rate Contract and for supply of JE Vaccine, Diluents, Auto disable syringe (AD) & Scalp vein set.

The following amendments in the tender may be taken note of prior to submission of bids.

- Clause no 5.5.4 "Delivery Period" will be modified and read as "Delivery period (Rev): Supply shall commence within best possible time from the date of order and supply of full quantity shall be completed within 90-120 days from the date of issuing the supply order.
- Clause no. 2. 5 "Quality Standard" will be modified and read as "Quality Standard" (Rev)
 - 2.5.1 Manufacturer of the drugs should hold a valid WHO-GMP/CE/USFDA/COPP (Certificate of Pharmaceutical Product) certificate issued by the appropriate Licensing Authority and Manufacturer of the Diluents, Auto disable syringe (AD), Scalp vein set should hold a valid GMP/WHO-GMP/CE/USFDA/COPP along with BIS & ISO 13485 certificate issued by the appropriate Licensing Authority.

The GMP/WHO-GMP/CE/USFDA/COPP along with BIS & ISO 13485 certificate must not be older than one year from the date of bid submission in the case where validity is not mentioned in the certificate.

- 2.5.2 In case the bidder is a Direct Importer then it should produce WHO-GMP/CE/USFDA/COPP (Certificate of Pharmaceutical Product) of the manufacturing firm.
- 3. Clause no. 2.3 "Market Standing of the Product" will be modified and read as Clause 2.3 "Market Standing of the Product" (Rev)
 - 2.3.1 Bidder should have at least 2 years' market standing as a manufacturer for the items quoted in the bid, as on the due date of submission of Bid. In the case of imported products, the product should have minimum 3 years standing in the market. The importer should have at least 2 years standing as manufacturer/

importer of items in general. Market standing of the product will be obtained from Competent Authority like Drug Control Deptt, or Deptt, of Chemical or Fertilizers or the Deptt. who has issued the license for production or Drug Control Deptt.

Explanatory Note: The merger/amalgamation/transfer of business/transfer of assets etc. of a firm affects the bid condition relating to Past Performance/Market Standing in preceding years. The eligibility of a bidder in this regard shall be ascertained by the Tender Committee on the basis of the stated Agreement/BOD Resolution/CA Certificate or any other document /certificate annexed with the tender.

This market standing condition would not apply to drugs which are introduced in India for less than 3 (three) years as on the due date of submission of Bid. A certificate from Drug Controller General (India)) shall be required for all such new drug formulations to this effect.

New drugs are those drugs which are defined as New Drugs" under Drugs and Cosmetics Act, 1940 and Rules there under as amended from time to time.

The market standing certificate as issued by the Drug Controller Authority for this tender should not be issued on a date earlier than $1^{\rm st}$ April, 2019.

4. Clause no. 3.2.13 "Execution of similar contracts" will be modified and read as "Execution of similar contracts" (Rev)

Details of supplies (Quoted items only) made during any of the last 5 financial years 2016-17, 2017-18 & 2018-19 supported by minimum one supply order copy (Attested/notarized copy/copies of Purchase Order/Orders for each quoted item/ items) during any of the FY 2014-15, 2015-16, 2016-17, 2017-18 & 2018-19 in Govt. organizations either directly in the name of the manufacturer or through authorized distributor (wherein the Supply Order the name of the manufacturer has mentioned clearly) must be submitted with the Bid and the same should be filled up accordingly in the specified format (Annexure-IV).
