INVITATION FOR BIDS (IFB)

The Office of the Mission Director, National Rural Health Mission, Assam, Guwahati-5 invites bid for the works under NRHM as detailed below **ON TURN KEY BASIS** and **ON TWO BIDS SYSTEM**.

1. Eligibility Criteria:

- Registered APWD (Bldg) Class I-(A) / CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking
 - Contractor must have satisfactory completed
 - Four similar works, each of value not less than 25% of the estimated cost put on tender or
 - Three similar works, each of value not less than 40% of the estimated cost put on tender or
 - Two similar works, each of value not less than 50% of the estimated cost put on tender or
 - One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited.
 - Contractor must have achieved Annual Turnover of at least Rs.9.00Crores in any **TWO YEARS** during last 5 years.
 - In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital Building projects on earlier occasion.
 - The contractor who was earlier allotted any NRHM works by PWD(B), Assam or by NRHM and could not complete the work in all respect **in time** will not be **ELIGIBLE** to participate in the bidding process.
 - The contractor and to whom extension of time was granted from NRHM imposing penalty will also be not **ELIGIBLE** to participate in the bidding process.
 - The intended bidders are asked to verify the site for the work prior to quoting their rates.
- Cost of tender document should be drawn in favour of **State Health Society, Assam**, payable at **Guwahati** in the form of Pay Order/Demand Draft.
 - Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the **State Health Society, Assam**, payable at **Guwahati**.
 - Pre-bid meeting date and time: **01/07/2013 at 16-00 hrs.**
 - Date for issuing of Bid Document: **26/06/2013 to 03/07/2013**
 - Last date and time of submission of Bid: **03/07/2013 at 14:00 hrs at the office of the Mission Director, NRHM, Assam.**
 - In case, if any Bandh/Holiday falls in any sequence, the sequence will be held in the next working day.
