This has reference to the e-tender No: NHM/PROC/HOSP-FURNITURE/3100/2016-17/24185 Date:07/12/2019 invited from manufacturers or authorized distributors/dealers for entering into two years rate contract for **"Supply of Hospital & Office Furniture"** to health institutions in different districts of Assam."The following amendment and clarification may be taken note of prior to submission of bids.

1. Sub-clause 1.4.5 of Clause 1.4 "ELIGIBILITY CRITERIA" is amended to read as follows:

Manufacturer/Manufacturers whose products have been quoted should have valid **CE/USFDA**, **ISO 13485:2016**, **BIFMA**, **ISO 9001:2015**, **OHSAS 18001:2007**, **ISO 14001:2015** certificates etc. as specified at Annexure XI

2. <u>Sub-clause 1.5.7 of Clause 1.5 "GENERAL CONDITION" is amended to read as follows:</u>

The clause "Price Preference/ Purchase Preference to PSUs / SSI Units shall not be applicable "is **deleted** from the scope of general tender condition.

25% share preference and 20 % price preference shall be accorded to the registered Micro and Small Enterprises located in and operating from within the State of Assam subject to the production of valid registration certificate, only with respect to the goods manufactured by them .

Preference will not be given for the product not manufactured by the MSME unit.

3. Sub-Clause 1.13.4 is added under Clause 1.13 "SUPPLY AND SERVICE CONDITION" as below:

The Manufacturer /authorized dealer should have at least a central Service Center located at Guwahati, Assam and the same should be equipped with necessary spares and manpower to provide prompt service within 48 hours of the complaint raised.

4. Sub-Clause 1.2.8 under Clause 1.2 " IMPORTANT NOTES" is amended to read as below:
