**NOTICE INVITING TENDER (NIT)**

The Office of the Mission Director, National Health Mission, Assam invites bid for the works under NHM in single bid system (in F2 form) affixing court fee stamp of Rs.8.25 (Rupees Eight and Twenty Five Paise) only for the works as detailed below:-

1. **Eligibility Criteria:-**

- Registered APWD (Bldg) Class I-A, B, C/Class-II/Class-III/CPWD Contractors/Reputed Const. Company/Agency registered under Govt./ Public sector undertaking.
  - Contractors having at least one similar nature of completed work valued at not less than 80% of the proposed project cost during last 3 (Three) years.
  - The Contractor having PAN Card/GST Registration/ Labour Licence / registration under EPF and MP ACT 1952 etc, are **ELIGIBLE** to participate in the bid process.
  - In case the evaluated bid amounts are equal, preference for allotment of the project will be given to the bidder who has completed Building works under NHM on earlier occasion.
  - The intended bidders are asked to verify the site for the work prior to quoting their rates.**
  - The intending bidders or their authorized representatives are to be present at the time of opening of Bids. Otherwise the bids will be opened in their absence and no claim will be entertained in future.
- Cost of tender document should be drawn in favour of **State Health Society, Assam**, payable at Guwahati in the form of Pay Order/Demand Draft.
  - Bid security with a validity of 225 (i.e. 180+45) days should be in the form of **TDR/FDR/CDR** and drawn in favour of the State Health Society, Assam, payable at Guwahati.
  - Date of receipt of application along with cost of tender document and copies of documents as per eligibility criteria mentioned at Sl.1 (a), (b) & (c) to issue Bid Document :- **20<sup>th</sup> Jan' 2020** during working hours.
  - Last date for issuing of Bid Document:- **27-01-2020 up to 17- 00 hrs.**
  - Last date and time of submission of Bid:- **29-01-2020 at 14-00 hrs.**
    - The bids will be opened at **15.30 hrs.** of **30<sup>th</sup> Jan' 2020**.
