SHORT NOTICE INVITING TENDER FOR EMERGENCY PROCUREMENT

OF

Speedy Construction of 300 Bedded COVID-19 Hospitals at Lakhimpur, Dibrugarh, Bongaigaon, Silchar and Guwahati using Pre-Fabricated Modular Construction Technology on Turnkey Basis under NHM, Assam

Sealed Tender affixing non refundable court fee stamp/IPO of Rs. 8.25 is hereby invited from the intending firm /contractor for "Speedy Construction of 300 Bedded COVID-19 Hospitals at Lakhimpur, Dibrugarh, Bongaigaon, Silchar and Guwahati using Pre-Fabricated Modular Construction Technology on Turnkey Basis under NHM, Assam in Built & Transfer Mode in one package along with ICU & ventilator equipped " in complete stage for functioning including all facilities as per following specification and terms and conditions.

A) Description of the location of the Scope of Work:

1) Lakhimpur, 2) Dibrugarh, 3) Bongaigaon, 4) Silchar and 5) Guwahati in one package

B) The following documents are to be duly enclosed with the quotation.

1. The bidder must be registered as a company or a limited liability firm as per provisions under appropriate law.
2. The bidder must have an annual turnover of Rs. 500 Crore during the last three financial years (i.e. FY 2016-17, 2017-18, 2018-19).
3. The bidder must not have been debarred by any government entity in India as on the last date of bid submission.
4. The rate quoted shall include all statutory taxes as per current Govt. rules in the state.
5. The bidder must have prior experience of setting up of Hospitals at least 50 beds capacity using the pre-fabricated construction technology.

C) Preparation & Submission of Bids:

Bidders are required to prepare technical and financial proposals separately and the same shall be uploaded in the separate folders at the time of submission of bids on the portal.

D) Evaluation of Bids:

1. Eligibility : Bidder' eligibility shall be assessed against the four eligibility criteria mentioned above. Only those bidders who meet all the eligibility criteria shall be considered for further evaluation.
2. Technical Evaluation: Technical Proposal submitted by the bidder shall be evaluated on the following parameters.

- a) Relevant experience of the Organization in Hospital Construction Sector.-10 Marks
- b) Designs, Layouts, Master-plan and Project Completed Schedule-60 Marks.
- c) Availability of Qualified resources-30 Marks

Bidders obtaining more than 70 marks in the technical evaluation shall be considered for financial bid opening . Proposals of bidders obtaining less than 70 marks shall be rejected.

E) Award of Contract:

The contract will be awarded to the technically qualified bidder offering the lowest price.
