(NATIONAL COMPETITIVE BIDDING)

Tenders in two Bid System (Technical Bid & Price Bid) affixing Court Fee Stamp of Rs. 8.25 (or IPO of Rs. 10.00 in favour of "State Health Society, Assam" for bidders located outside Assam) are invited from manufacturers/importers or authorized distributors/ dealer for supply of the **Viral Transport Media Kit, Viral RNA Extraction Kit, Real Time PCR Combo Kit** on an **urgent basis** in view of COVID-19 pandemic condition. The technical bid as well as financial bid (BOQ) is to be uploaded in assamtenders.gov.in. There is no requirement to submit the hard copy of neither technical bid nor financial bid.

1. **Specification:** As stated at Annexure-1 to this bid document.
2. **Total Quantity required= 50,000** against each item mentioned above (quantity is tentative; it may increase or decrease depending upon the case load and future emergency need).

3. **Delivery Destinations:** The selected bidder (or) bidders has to supply total ordered quantity to the designated State Ware House (CDWH, Narengi, Guwahati).
 4. **Delivery period:** 50 % of the quantity to be supplied within best possible time, maximum by 07 days or as specified in the P.O. Rest 50% by next 07 days. Items will be received after the expiry of stipulated time period only against the permission of the Tender Inviting Authority. A declaration to be submitted in this regard along with the technical bid.
 5. **Payment provision:** Payment will be made within best possible time, preferably within 1 week against submission of bill & receipted challan (in triplicate) with stock book entry details, from the receiving authority.
 6. **Product Shelf Life:** The labeled shelf life of items supplied should be not less than the 1 year. The remaining shelf life of the items at the time of delivery should not be less than $\frac{3}{4}$ of the labeled shelf life.
 7. **Approval/validation by ICMR:** The quoted Kit should be approved/validated by ICMR (Indian Council of Medical Research, Govt. of India). Documentary evidence in this regard must be submitted with the bid.
 8. The successful Bidder shall execute an agreement on non-judicial stamp paper of value Rs 100/- (stamp duty to be paid by the Bidder) within 7 working days from the date of issuing of Supply order.


B. Following documents are to be considered as the requisite documents to be selected as a technically responsive bidder and also to be considered as the documents of Technical Bid

- (i) **Constitution of the Company:** Documentary evidence regarding constitution of the bidding firm such as Certificate of Incorporation, Memorandum & Articles of Association, Partnership Deed etc. with details like Name, Address, Telephone Number, mobile no, Fax Number, E-mail, bank account details, IFSC code & bank Address of the firm with names of the Managing Director / Partners / Proprietor must be submitted with the technical bid.
- (ii) **Manufacturing License/ Import License:** If the bidder is a manufacturer: Attested/notarized copy of valid Manufacturing License of the quoted product of the manufacturer must be submitted along with the Bid. Original license should be produced if demanded for verification. **If the quoted item comes under Drugs & Cosmetic Act, the manufacturing license must be issued by the Drug Control Deptt. In case the item is an imported item than the valid Import license obtained from the must be submitted with the bid.**
- (iii) **Manufacturer's Authorization certificate:** If the bidder is an authorized distributor or dealer: where the bidder is not manufacturer, the "manufacturer's authorization certificate" from the principal manufacturer/importer is to be submitted with the bid along with Import License of the Indian distributor or dealer (if the item is an imported item).
- (iv) **Income Tax Return (ITR) Copies:** - Copies of Income Tax Return (ITR) Copies for last three financial years i.e. 2015-16, 2016-17, 2017-18 or 2016-2017, 2017-2018 & 2018-2019 must be submitted with the bid.

- (v) **Annual Turnover:** The bidder must have Average Annual Turnover 5.00 Crores during the last 3 Financial Year (2016-17, 17-18 & 18-19). Attested/notarized copies of audited "Profit & Loss Statement" and "Balance Sheet" must accompany the Annual Turnover Certificate as issued by the Auditor/Chartered Accountant for the corresponding period may be submitted.
- (vi) **Execution of similar contract:** Proof of previous experience in similar job of supply of diagnostic kit in any of the last 3 financial years (2016-2017, 2017-2018 & 2018-2019) is to be submitted with the bid.
- (vii) Copy of the **GST Registration Certificate and PAN Card** shall be submitted along with the bid.



- With sterile flocked nylon swab with breakpoint-2 nos. (nasopharyngeal & oropharyngeal)

- Purity of RNA A260/280 (Amount of protein contamination) ~2.0
