**NOTICE INVITING EoI**

EoI is here by invited from manufacturers for supply of the "**Essential Drugs**" on an **urgent basis** for the management & treatment of COVID-19 .

**A. Important dates:**

1. Tender download date & time: 11/08/2020 from 5.00 pm
2. Tender submission start date : 12/08/2020 from 10.00 am.
3. Tender submission End date : 14/08/2020 up to 3.00 pm.
4. Tender opening date (online): 14/08/2020 at 4.00 pm.

**B. Important Notes:- (Supplies shall be subject to the following terms & conditions):**

1. The complete set of tender documents may be downloaded from [assamtenders.gov.in](http://assamtenders.gov.in) or the official website of NHM <https://nhm.assam.gov.in>.
2. The technical bid as well as financial bid (BOQ) is to be uploaded in [assamtenders.gov.in](http://assamtenders.gov.in)  
Hard copy of the Technical bid is not required to be submitted.  
The Price Bid (BoQ) must be uploaded in the e-Tender portal.
3. **Name of the Drug with Tentative Required quantity & Approx. Financial Involvement:**
  - I. Tab Zinc I.P 50 mg IP @ pack of 1x10 Tab= 20,00,000 Tab
  - II. Tab Famotidine I.P 20 mg @ pack of 1x10 Tab=10,00,000 Tab
  - III. Tab Dexamethasone 6 mg I.P @ pack of 1x10 Tab= 2,00,000 Tab
  - IV. Tab Favipiravir 200 mg @ pack of 1x34 Tab= 34,000 Tab
  - V. Inj. Dexamthosone 6mg I.P 2ml amp=50,000 Amp
  - VI. Inj. Tocilizumab 200 mg/ 10 ml Vial = 2,000 Vial
4. Only Manufacturers are allowed to participate in the EoI.  
Distributor/Dealer are not allowed.

5. If a supplier fails to execute successive order within the stipulated time frame, in full, there will be an additional time of 7 days and after that the supply order will stand cancelled and that firm will be liable to debarred for the particular product, for a period of 6 months in NHM, Assam tender.
6. Any Bidder has been blacklisted or debarred by any State/UT Government /Central Government / its Drug Procurement Agencies due to quality failure or fraudulent/illegal practices of the drugs supplied will not be considered. Declaration on Blacklisting/Debarment of the bidder in the Non Judicial Stamp paper must be submitted with the technical bid.
7. The supply should preferably in Generic name but in view of emergency requirement in the field, brand name will also be accepted but the MRP should be stroked out from the pack to be supplied. For imported product the MRP may be kept as per the Import schedule
8. Payment will be made within best possible time from receipt and acceptance of materials at destination against submission of bill & receipted challan (in triplicate) with stock entry details.

**C. TECHNICAL BID:**

The EoI should be accompanied by attested/notarized copies of the following: **MARKED AS COVER -A: TECHNICAL BID** which will be also considered as **Eligible Criteria to be a technically responsive bidder:**

- (i) **Manufacturing License:** (without the same the EoI will be considered as incomplete)  
Attested/notarized copy **Valid Manufacturing License** of the quoted product along with the valid product permission of the quoted product must be submitted along with the EoI. Manufacturing License & Product permission should be obtained from Drug Control Authority only or DGHS (CDSCO).
- (ii) **Certification of WHO-GMP:** (without the same the EoI will be considered as incomplete)  
Attested/notarized copy of **Valid WHO-GMP** certificate of the manufacturer must be submitted with the EoI. Original certificate should be produced if demanded for verification.
- (iii) **Proprietary Certification:** If the drug is a proprietary item against which Drug Control Authority or DGHS (CDSCO) has given manufacturing/import license, the copy of the same should be enclosed with the EoI.
- (iv) Copy of the **GST Registration Certificate and PAN Card** shall be submitted along with the bid.
- (v) **Instant supply Capacity of the bidder** (must be fill up and submit in **Non-Judicial** stamp paper with technical bid and without the same the EoI will be considered as incomplete)  
**The instant supply capacity of the bidder must be more than 70% of the EoI requirement (either by 3 days or 7 days or 10 days) mentioned above and without the same capacity, the EoI will not be considered.**
