<u>e-SHORT TENDER</u> NOTICE INVITING e-Tender for Body Bags (for COVID-19)

e-Tender is here by invited from manufacturers/ importers for supply of the <u>"Body Bags"</u> on an urgent basis in view of COVID-19 pandemic.

A. Important dates:

B. Important Notes:-(Supplies shall be subject to the following terms & conditions):

- 1. The complete set of tender documents may be downloaded from <u>assamtenders.gov.in</u> or the official website of NHM https://nhm.assam.gov.in.
- 2. The technical bid as well as financial bid (BOQ) is to be uploaded in <u>assamtenders.gov.in</u> Hard copy of the Technical bid is not required to be submitted. The Price Bid (BoQ) must be uploaded in the e-Tender portal. In any circumstances if any bidder will submit the Technical Bid or Price bid hard copy, the same bid will be rejected automatically.

- 4. **Delivery Destination**: Items will be supplied to NHM, SHQ, Store-Central Drug Ware House, Narengi, Patharquarry, Guwahati-781071, Dist: Kamrup-Metro, Assam as per the schedule in the bid or as per the schedule in P.O to be placed to the selected vendor.
- 5. Only **Manufacturers/importers** are allowed to participate in the <u>bid</u>. Distributor/Dealer are not allowed to participate.
- 6. **Delay Penalty**: If a supplier fails to execute successive order within the stipulated time frame, in full, there will be an additional time of 7 days and after that the supply order will stand cancelled and that firm will be liable to debarred for the particular product, for a period of 6 months in NHM, Assam tender.
- 7. Any Bidder has been blacklisted or debarred by any State/UT Government / Central Government / its Drug Procurement Agencies due to quality failure or fraudulent/illegal practices of the drugs supplied will not be considered. Declaration on Blacklisting/Debarment of the bidder in the Non Judicial Stamp paper must be submitted with the technical bid.
- 8. Payment will be made within best possible time from receipt and acceptance of materials at destination against submission of bill & receipted challan (in triplicate) with stock entry details from the delivery destination. Items will be supplied to NHM, SHQ, Store-Central Drug Ware House, Narengi, Pattharquwary, Guwahati-781071.

C. TECHNICAL BID:

The tender should be accompanied by attested/notarized copies of the following: MARKED AS COVER -A: TECHNICAL BID which will be also considered as Eligible Criteria to be a technically responsive bidder:

(i) Manufacturing License/Manufacturing permission/ Product Permission: (without the same the bid will be considered as incomplete)

Attested/notarized copy Valid Manufacturing License/Permission for manufacturing the Body Bags/ Product Permission from the Competent licensing Authority must be submitted along with the Bid.

- (ii) Execution of the Similar Contract (without the same the bid will be considered as incomplete):

 The Manufacturer/Importer must have experience of supply of quoted item (Body Bags) in Govt. organization or reputed private organization & the copy of the supply order obtained in favour of quoted item (Body Bags) within the period 30/06/2020 must be enclosed with bid.
- (iii) Quality Certification: Bidder must submit Attested/notarized copy below mentioned certification which must also be valid on the day of tender dropping.
 ISO 16602:2007 / ISO 16603:2004 / ISO 16604:2004/ ISO-DIS 22611:2003

(iv) Annual Turnover: (without the same the bid will be considered as incomplete)

The Average Annual Turnover of the Manufacturer/Importer 5.00 Crores during the last 3 Financial Year (17-18 & 18-19 & 19-20) shall not be less than Rs 5.00 Crores& certified copy on Annual Turnover from Chartered Accountant with UDIN must be submitted with the bid. For domestic MSME/SSI Units, the Average Annual Turnover in the last three financial years of the manufacturer/importer in the last three financial years 17-18 & 18-19 & 19-20 shall not be less than Rs 2.00 Crores.

Attested/notarized copies of audited "Profit & Loss Statement" and "Balance Sheet" must accompany the Annual Turnover Certificate as issued by the Auditor/Chartered Accountant for the corresponding period must be submitted with the bid.

- (v) Copy of the GST Registration Certificate and PAN Card shall be submitted along with the bid.
- (vi) <u>Instant supply Capacity of the bidder</u> (must be fill up and submit in Non-Judicial stamp paper with technical bid and without the same the <u>Bid</u> will be considered as incomplete) <u>The instant supply capacity of the bidder must be more than 80% of the EoI requirement (either by 7 days or 10 days or 15 days) mentioned above and without the same capacity, the EoI will not be considered.</u>
