- The following amendments in the tender may be taken note of prior to submission of bids.

Para	Original Provision	Amended Provision
2.3.1	Bidder should have at least 2 years' market standing (FY 2018-19 & 2019-20) as a manufacturer for the items quoted in the bid, as on the date of bid opening. In the case of imported products, the product should have minimum 2 years standing (FY 2018-19 & 2019-20) in the market. The importer should have at least 2 years standing as manufacturer/importer of items in general. Market standing of the product will be obtained from Competent Authority like Drug Control Deptt. or Deptt. of Chemical or Fertilizers or the Deptt. who has issued the license for production or for item which doesn't come under Drugs & Cosmetic Act, the said market standing will be obtained from Chartered Accountant but the certificate should be verified with UDIN.	Market standing condition would not applicable to “Dual Kit for Screening of HIV and Syphilis” as the concept has introduced in India very newly in regards to Dual Elimination of Mother to Child Transmission (EMTCT) of HIV & Syphilis. Hence, at least 2 years' market standing (FY 2018-19 & 2019-20) is here by revoked for Dual Kit for Screening of HIV and Syphilis”. But a certificate from Drug Control Deptt. General (India) shall be required for both domestic/imported to this effect regarding valid manufacturing license or valid import license.

3.2.13	Execution of similar contracts : Details of supplies (Quoted item only) made during any of the last 3 financial years 2017-18, 2018-19 & 2019-20 supported by minimum one supply order copy (Attested/ notarized copy/ copies of Purchase Order/ Orders for each quoted item/ items) during any of the FY 2017-18, 2018-19 & 2019-20 in Govt. organizations either directly in the name of the manufacturer or through authorized distributor (where in the Supply Order the name of the manufacturer has mentioned is to be submitted. If the supply order is in brand name, the product leaflets/ product catalogue/ product brochure must be enclosed to the tender where the generic specification should be displayed clearly) must be submitted with the Bid. All details should be filled up accordingly in the specified format (Annexure-IV).
