RFQ is here by invited from suitable Transporting Firm for <u>TRANSPORTATION OF DRUGS/SURGICALS/EQUIPMENTS/KITS/GOODS/IEC MATERIALS to District Warehouses, Medical Colleges of Assam and Covid Care Centres of Assam under NHM on urgent basis for a period of at least 90 days</u>

B. Important Notes on terms & conditions for the bidders:

- 1. The RFQ may be downloaded from the official website of NHM https://nhm.assam.gov.in.
- 2. The last date of submission of RFQ is 21/12/2020.
- 3. The RFQ should be sealed and signed by the Agency and Court Fee stamp of Rs. 8.25 must be attached.
- 4. Minimum one year of experience (as on 31st Oct 2020) in providing Transportation Services (Copy of the Service Contract/Work Order to this effect to be enclosed as supporting evidence along with the technical proposal).
- 5. Both hard copy of RFQ (consider as technical document) & Price Bid (as cover B) to be submitted together inside a single sealed & super scribe as 'RFQ' for Transportation
- 6. Copy of the GST Registration Certificate and PAN Card shall be submitted along with the bid.
- Bidder should hold valid **Trade License** issued by the competent authority to be submitted with Techincal proposal
- **8.** Bidder should have a registered office at Guwahati for more than one year as on date of bid submission or the Transporter firm should be registered under Trade Licening Authority of Kamrup (M) /Kampur (R).
- 9. Average Annual turnover of the bidder in the past three financial years i.e. 2017-18, 2018-19, 2019-2020 shall not be less than Rs.20.00 Lakhs to be certified from CA
- 10. Loading and Unloading of the goods is the sole responsibility of the transporter. **The price quoted will be for** one way only i.e. from the point of loading and unloading at the destination only.
- 11. The vehicle may be provided as and when required depending upon the emergent situations to send the drugs/surgical/equipments/goods/IEC-materials to the desired destinations immediately.
- 12. In case, the goods to be transported are nominal in volume and falls in the same route, the transporter should ensure transportation of all the materials at a time subject to feasibility.

- 13. Arrangement of Road Permits and Toll gate fees during transportation of consignments shall be the responsibility of the Transporter only.
- 14. Vehicle should be arranged within a short notice like 2 3 hrs during emergency.
- 15. The delivery should be completed within two days or unless otherwise specified in the work order. Any delay will be penalized @.05% per day up to maximum 10% if additional extension will not be granted by the Tender Authority.
- 16. In the event of any dispute arising out of the RFQ such dispute would be subject to the jurisdiction of the Court within the State of Assam only.
