- a. Registered APWD (Bldg) Class -I(C) & Class II / CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking.
- b. Contractors having completed works in any one year during last five years 90% of contract value & atleast one similar nature of completed work value not less than 30% of the proposed project cost.
- c. The contractor who was earlier allotted any NRHM works by PWD (B), Assam or by NRHM and could not complete the work in all respect <u>in time</u> will not be **ELIGIBLE** to participate in the bidding process.
- d. The contractor & to whom extension of time was granted from NRHM imposing penalty will also not be **ELIGIBLE** to participate in the bidding process.
- The contractor who was earlier allotted any NRHM works and work progress is not satisfactory will
 not be **ELEGIBLE** to participate in the bidding process.
- 2 Cost of tender document should be drawn in favour of State Health Society, Assam, payable at Guwahati in the form of Pay Order/Demand Draft.
- 3 Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the **State Health Society, Assam,** payable at **Guwahati**.
