NOTICE INVITING TENDER (NIT)

The Office of the Mission Director, National Health Mission, Assam invites bid for the following works under NHM in single bid system (in F2 form)affixing court fee stamp of Rs.8.25 (Rupees Eight and Twenty Five Paisa) only for the works as detailed below:-

1. Eligibility Criteria:-

(a). Registered APWD (Bldg) Class I-A,B,C/Class-II& /Class-III/CPWD Contractors /Reputed

Construction Company/Agency/registered under Govt./ Public sector undertaking having relevant experience as

detailed table above are eligible to participate in the bid.

(b).Contractor must have satisfactory completed:-

- i) Three similar works, each of value not less than 40% of the estimated cost put on tender OR
- ii) Two similar works, each of value not less than 50% of the estimated cost put- on tender OR
- iii) One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 7years ending on the last day of the month previous to the one in which the tenders are invited.

(c).Contractor must have achieved average annual turn-over of at least 30% of estimated cost during last 3 years ending 31st March of the previous Financial Year.

(d).The Contractor having PAN Card/GST Registration/Labour License/registration under EPF & MP Act, 1952 etc. are eligible to participate in the bid process.

(e). The intended bidders are asked to verify the site for the work prior to quoting their rates.

- Cost of tender document should be drawn in favour of State Health Society, Assam, payable at Guwahati in the Form of Pay Order/Demand Draft.
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of FDR/CDR/TDR and drawn in favour of the State Health Society, Assam, payable at Guwahati.
- Date of receipt of application along with cost of tender document and copies of documents as per eligibility criteria mentioned at SI.1 (a), (b) & (c) to issue Bid Document: - <u>09-11-2021 to 16-11-2021</u> during working hours.

5. Date and time of submission of Bid:- **<u>09-11-2021</u>** to **16-11-2021** up to 14-00 hrs.
