SPECIAL TERMS AND CONDITION

Name of work: Comprehensive Annual Maintenance of Air Conditioner Machine of O/o the Mission Director, NHM, Assam at Saikia Commercial Complex, Christian Basti Guwahati-5 for the year 2022-23.

- All the ACs installed at NHM office complex should remain functional continuously throughout the year. The firm / contractor should provide regular supervision of the machines with required 1. qualified technician.
- The contractor / firm should posses the required T&P materials like gas cylinder, flaring tools, 2. clamp gas charging pipe, vacuum pump, leak detector etc.
- The required spare materials should be kept ready at site so that it can be used immediately as and when required. The maintenance rate quoted should cover the cost of spares and no any 3. payment for any type of spare parts will be paid separately, including replacement of Compressor.
- The engaged staff should have suitable coverage by insurance package so that they can claim their benefits in case of any disaster. This office will not entertain any sort of compensation, 4. accidental benefit to any staff of the firm / contractor in case of accident.
- All damaged materials should be replaced by the firm / contractor immediately to prevent from 5. any sort of breakdown.
- A register should be be maintained in this office for recording periodical checking of AC Machines and should be signed by the in-charge of the firm. The reporting time & date of defect of any AC 6. Machine should be in the register.
- Replaced materials should be of same brand as the brand of the machine. 7.
- During the contract period, the firm / contractor will be fully responsible for the malfunction of 8. any machine.
- Engaged technicians should be provided by the firm / contractor with identity cards. 9.
- Penalty will be imposed upon the firm / contractor, if any AC Machine remains non functional 10. more than 24 (twenty four) hours from report time of defects @ Rs. 210/- per day. If any legal dispute over the implementation of the provisions of the terms of reference if arises will be settled within the jurisdiction of Assam only.
- The work shall be carried out in accordance with general specification for electrical works and Electricity Rules 1956 as amended up to date as and as per all relevant I.S. codes and Indian 11. Electricity Rules.
- Sales Tax, excise duty, octopi or any tax livable on materials in respect of contract shall be 12. payable by the firm / contractor. The department will not entertain any claim what so ever in
- The contractor / firm have to submit 2% security deposit in the form of Call Deposit / Fixed 13. Deposit in favour of State Health Society, Assam during allotment of work.
- The job contract is awarded initially for a period of one year. It extendable for another one 14 year based on review of performance. However, the terms of agreement may be discontinued by giving 1(one) month notice, if the performance is not satisfactory and in case of misconduct.
- Payment will be made on quarterly basis as per assessment made by Engineer in charge. 15.
- The Firm/Contractor must engaged dedicated Manpower for repair & maintenance of AC 16. machines during office working hours.
