A) Special Terms and Conditions-

Interested firm/contractor may contact the construction cell, Office of the Mission Director for any details in office hours.

1. Details electrical installation consist of service connection, panel board, wiring, power line, AC Machine, Air Curtainer, DG connection and earthing etc.
2. Machine and equipments are Servo Voltage Stabilizer, UPS, Radiant warmer, Oxy-Meter, Pulse Meter, Phototherapy Machine etc.
3. The proposer has to submit 2% as bid security on the proposed rate in favour of State Health Society, Assam Payable at Guwahati in the form of TDR/FDR valid for 1 year issued through Nationalized bank.

B) Purpose of the Activity

1. To identify the gaps in various electrical system including distribution transformer and network, cable and transformer, earthing, backup system & any other electrical system etc. accordance with standard.
2. To identify the gaps, if any, in power supply/electrical design and consumption.
3. Establish recommendations for best practice in operation and maintenance of electrical system.
4. Establish recommendations towards continuous, breakdown free electricity for equipments.
5. Provide training on best practices audit recommendation and safety requirements to the electricians/O&M personnel.

C) Approach Methodology

A team consisting of experienced Power Quality and Safety Auditor will be deployed for conducting the audit and training of personnel.

Instrument deployed for onsite measurement will include Three Phase/Single Phase Power Analyzers, Earth Tester, Meger for insulation resistance measurements, Clamp Meter for current measurements etc.
