 - (ii) Two similar works, each of value not less than 50% of the estimated cost put on tender or
 - (iii) One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last Seven (7) years ending on the last day of the month previous to the one in which the tenders are invited.
- (c) Contractor must have achieved Annual Turnover of at least 30% of estimated cost in any 3 YEARS during last 5 YEARS.
- (d) The Contractor having PAN Card/GST Registration/Labor License registration under EPF & MP Act, 1952 etc. are eligible to participate in the bid process
- (e) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital Building projects on earlier occasion.
- (f) The intended bidders are asked to verify the site for the work prior to quoting their rates.
